



# Lane closure on A413, Little Missenden, Buckinghamshire, for works surveys.

High Speed Two (HS2) is the new high speed railway for Britain. This notice is to inform you of additional temporary lane closures on the A413, Little Missenden, to take readings from that equipment.

# How will these works affect you?

A short section of the inside lane on the A413 dual carriageway towards Aylesbury will be temporarily closed to traffic. We will use traffic management to narrow the lane, leaving the outside lane open allowing traffic to flow whilst we take our readings.

The lane closures will be in place from 9.30am to 3.30pm on:

- Wednesday 1 March
- Monday 27 March
- Friday 24 April
- Access to Mop End Lane will be maintained at all times
- Further dates are to be confirmed

We aim to meet our planned working dates, but these can change due to the impact of the weather or programme changes. We will do all we can to keep you updated.

### What will we be doing?

A small team of surveying engineers will be visible in the highway whilst taking readings from the monitoring equipment. To do this safely, a small section of the inside lane on the A413 will be temporarily closed.

#### Why are we doing these works?

I&M surveys are carried out along the highway as it is a hard surface that provides an accurate reading, unlike soil or softer ground which can move. We need to obtain this above surface as well as below ground, from vent shaft to vent shaft, to ensure correct alignment of the Chiltern tunnel. These surveys will be carried out monthly in 2023 as the TBMs travel through Little Missenden.


