High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing.

We will be diverting additional utilities on the A429 Coventry Road between Coventry and Kenilworth. This is required in advance of the new bridge and to maintain site access on the A429.

When will these works be taking place?

These works will be carried out from **27 March 2023 to 31 March 2023** between **8am** and **6pm**. Temporary traffic lights will be in operation between **9.30am** and **3.30pm** on these dates. See map below for the location of the works.

Two-way temporary traffic lights from 27 March 2023 to 31 March 2023. Our working hours will be 8am to 6pm

Minimal disruption to local journeys

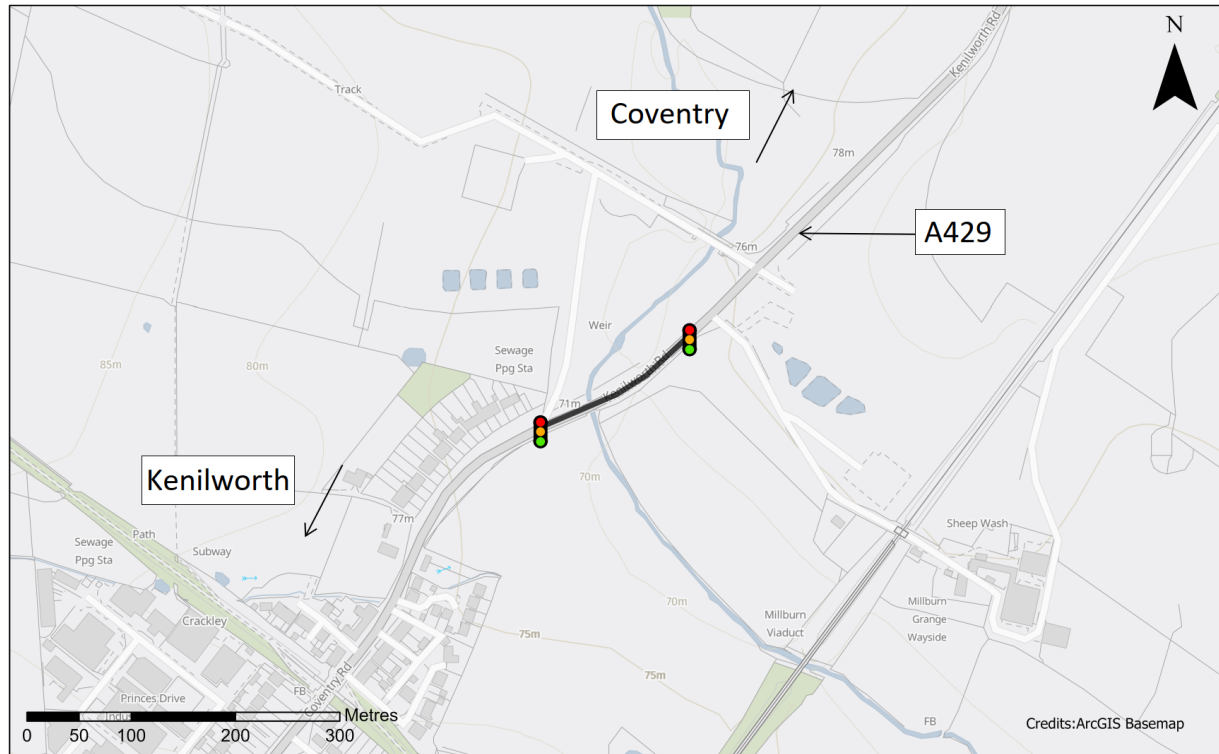
