



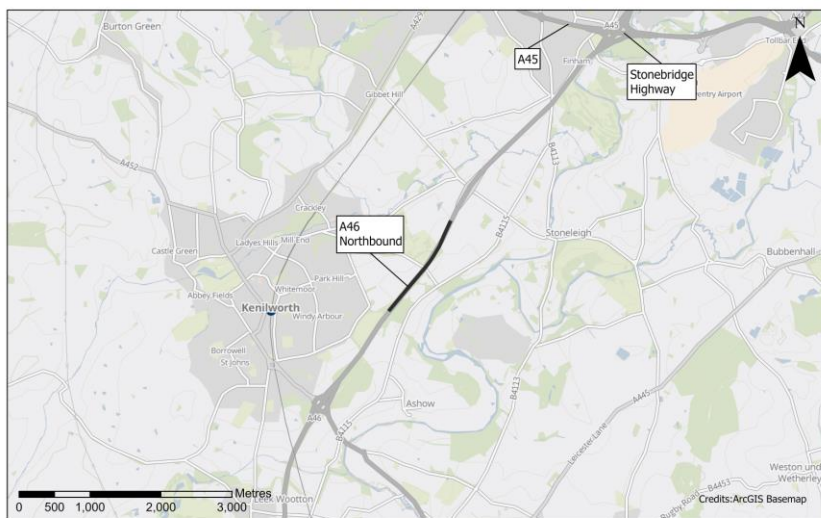
Notice of A46 Kenilworth Bypass, overnight lane closure near Stoneleigh

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We will be carrying out overnight works to install temporary safety barriers along the A46 Kenilworth Bypass on Wednesday 12 April and Thursday 13 April 2023 from 8pm to 6am each night.

Our works will involve reducing the lanes on the A46 to a single lane northbound between Thickthorn Interchange (Leamington) and the Stoneleigh Junction. The work will be subject to consent.
