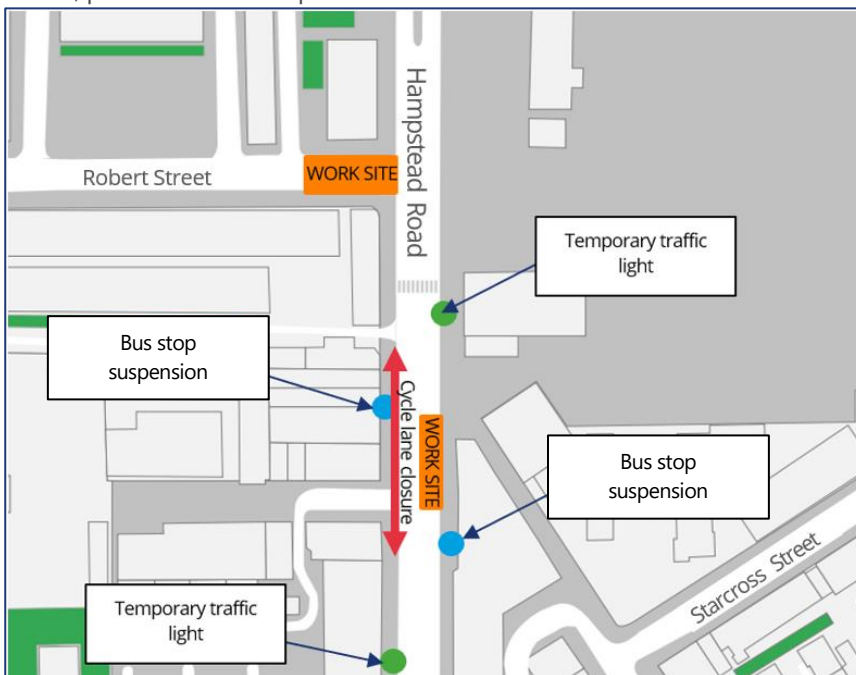
High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.

Sewer surveys on Robert Street and Hampstead Road between 13 and 17 March 2023

As part of our essential programme of utilities works, we need to carry out CCTV surveys on the existing sewer to check its condition and collect information to assist with design works. The sewer manhole is located on Robert Street within the existing temporary work site and also at the junction of Hampstead Road/ North Gower Street.

Access to the manhole to carry out these surveys is required **for approximately four nights in mid-March 2023**. These surveys can only be carried out at night given that water flows are lower which means we can collect more accurate survey results. For location and traffic management details, please refer to the plan below.



We will ensure every effort is made to minimise unnecessary noise.

Duration of works

- 13 to 17 March 2023
9pm to 5am
- Start-up and close-down activities up to one hour before and up to one hour after working hours above

What to expect

- Temporary worksites where work is taking place
- Traffic management in place
- Pedestrian access will be maintained
- Suspension of parking bays
- Noise and vibration
- Dust suppression

- Aim to reduce noise and vibration as reasonably practicable
- Keep all sites safe and secure
