



## Notice of Wendover overnight road closures for survey works

### What are we doing?

To help us finalise the detailed designs of the new railway and ensure we can reinstate features after construction has been completed, we are required to survey the area regularly. Surveying is used to establish the locations and sizes of walkways, buildings, underground utilities, road layouts and more.

We will be undertaking overnight surveys along a section of London Road, A413 London Road, Wendover Bypass, Nash Lee Road and Nash Lee Lane.

To carry out these surveys safely and effectively we will introduce an overnight road closure between South Street and the Nash Lee Road/Wendover Bypass roundabout throughout the duration of these works.

Resident access for Hale Road (west side only), Chapel Lane, Heron Path, Bacombe Lane and Witchell along with emergency access will be maintained throughout.

### When will these works take place?

- Full overnight closures of London Road, A413 London Road, Small Dean roundabout, Wendover Bypass – Monday 3 April – Friday 7 April (8.30pm – 5.30am)
- Lane closure and temporary traffic lights, Nash Lee Road and Nash Lee Lane (8.30pm – 5.30am)

These dates are subject to change due to circumstances beyond our control. Should we finish the works early, the lane closures will be removed.

Full overnight closure will commence Monday 3 April to Friday 7 April.

Road closure timings:

- 8.30pm – 5.30am

Lane closures on Nash Lee Road and Nash Lee Lane commence Wednesday 19 April to Saturday 22 April:

- 8.30pm to 5.30am

### What to expect

Varied activities with both quiet and busier periods.

Overnight closures on London Road, Small Dean roundabout and the Wendover Bypass with fully signposted diversion route.

Overnight lane closure with temporary traffic lights on Nash Lee Road.

### What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

Take care to respect the community.


