# Mandeville Road Ventilation Shaft - Easter Weekend Work

We have recently been speaking to residents about our work at the Mandeville Road Vent Shaft site. We are looking to use the Easter Weekend to carry out necessary works.

This work will be steel fixing within the main shaft which will take place from **8am to 6pm every day from Friday 7 April until Monday 10 April**. You may notice a crane operating at the lower level, and personnel working at the same level. We are carrying out as little work as possible and will ensure to have all mitigations in place to reduce disruption. We do not plan to have HGVs accessing the site on the Bank Holidays, there may be a small number of HGVs accessing the site on Saturday and Sunday.
