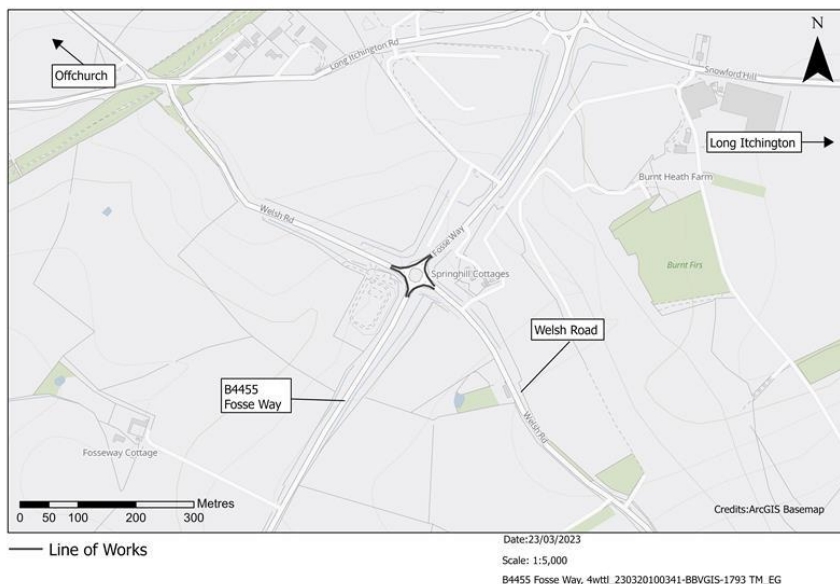
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We will be removing and replacing a damaged signpost on the southside of the roundabout at the Fosse Way and Welsh Road junction. Due to high traffic volume, to maintain the smooth flow of traffic and to carry out this work safely, we need to install four-way temporary traffic lights at the roundabout during the day.

When will the works take place

The works will take place from **17 to 21 April 2023**, with the temporary traffic lights operating from **9.30am to 3.30pm**, to reduce disruption the traffic, the lights will be switched off during peak hours.
