High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will do

We are carrying out works to create a safe access into our compound, at Middleton House Farm, off the A4091. To complete this access we will need to work along a section of the A4091 carriageway.

We will also undertake work on Bodymoor Heath Lane to install traffic signage for our site access.

To ensure we can complete these works safely we will install temporary traffic management at these locations.

When the work will take place

To complete these works safely we will require the following traffic management:

A4091

Single lane closure with temporary three-way traffic lights (24 hours) on the A4091 and the access into our compound at Middleton House Farm on:

• Tuesday 11 April to Sunday 16 April 2023.

We will also close the layby at this location, on the A4091, over this period.

Bodymoor Heath Lane

Single lane closure on Bodymoor Heath Lane with temporary two-way lights between 9.30am to 3.30pm on:

Tuesday 11 April to Wednesday 12 April 2023.


