



Notice of traffic management on A453 Sutton Road and Drayton Lane

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will do

We are completing a utility diversion on the A453 Sutton Road and Drayton Lane.

These works will require us to excavate a section of the A453 Sutton Road and the verges. To ensure we can complete these works safely we will install temporary traffic management to manage the flow of traffic and ensure the safety of road users.

When the work will take place

To complete these works safely we will require the following traffic management:

Single lane closure with temporary three-way traffic lights between 9.30am to 3.30pm (Mon-Fri) on:

- **A453 Sutton Road / Drayton Lane** from **03 April** to **14 April 2023** (Excluding the bank holidays on 07 and 10 April 2023).

Single lane closure with temporary two-way lights (24 hours) on:

- **A453 Sutton Road** from **17 April** to **24 April 2023**.

Single lane closure with temporary three-way traffic lights between 9.30am to 3.30pm (Mon – Fri) on:

- **A453 Sutton Road / Drayton Lane** from **25 April** to **05 May 2023**

Temporary traffic management from 03 April to 05 May 2023.

Our working hours will be 8am to 6pm (Mon-Fri) and 8am to 1pm (Sat)

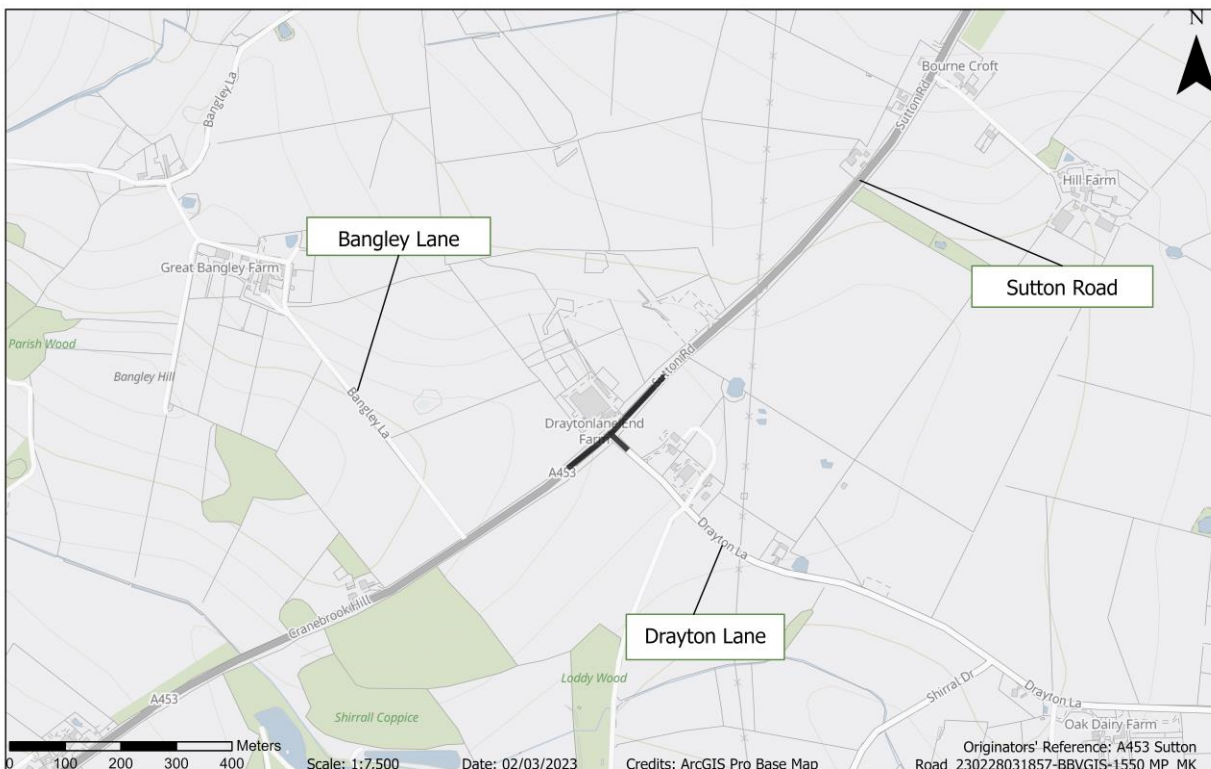
