



Notice of traffic management on Watling Street, Hints

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing.

We will be commencing the construction of Watling Street overbridge that will allow HS2 to pass under Watling Street. To minimise the impact on road users, while we construct the bridge, we will build a temporary diversion, on land next to Watling Street. Once completed we will divert traffic onto the new temporary road which will minimise future disruption and closures of Watling Street.

This work will be completed in phases:

Phase 1 - Completing works for the temporary road diversion.

We will install temporary traffic lights from Monday 3 April to Friday 28 April 2023. During the first week the traffic lights will be in place from 8am to 6pm. Following this the traffic lights will be in place 24 hours a day until Friday 28 April 2023.

We will be reducing the speed limit on Watling Street from 50mph to 30mph.

Phase 2 - Completing the connections and opening the new temporary Watling Street diversion.

To complete the connection between the new temporary diversion and the existing Watling Street we will close Watling Street from 8pm on Friday 28 April to 5am on Tuesday 2 May 2023 (24 hours).

A signed diversion route will be in place during the closure.

Once the diversion has been assessed, to ensure it is safe for road users, we will re-open Watling Street.

Duration of works

Phase 1

Temporary traffic lights from Monday 3 April to Friday 28 April 2023

Our working hours will be 8am to 6pm (Mon-Fri) and 8am to 1pm (Sat)

Phase 2

Full closure of Watling Street from 8pm on Friday 28 April to 5am on Tuesday 2 May 2023

The closure will be in place 24 hours a day

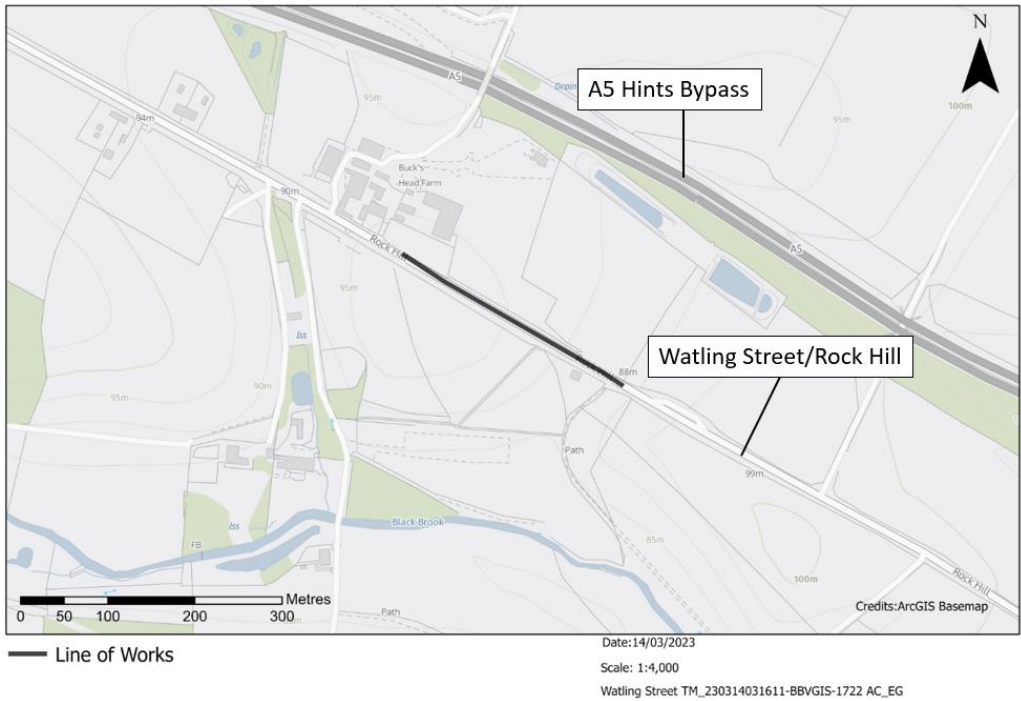

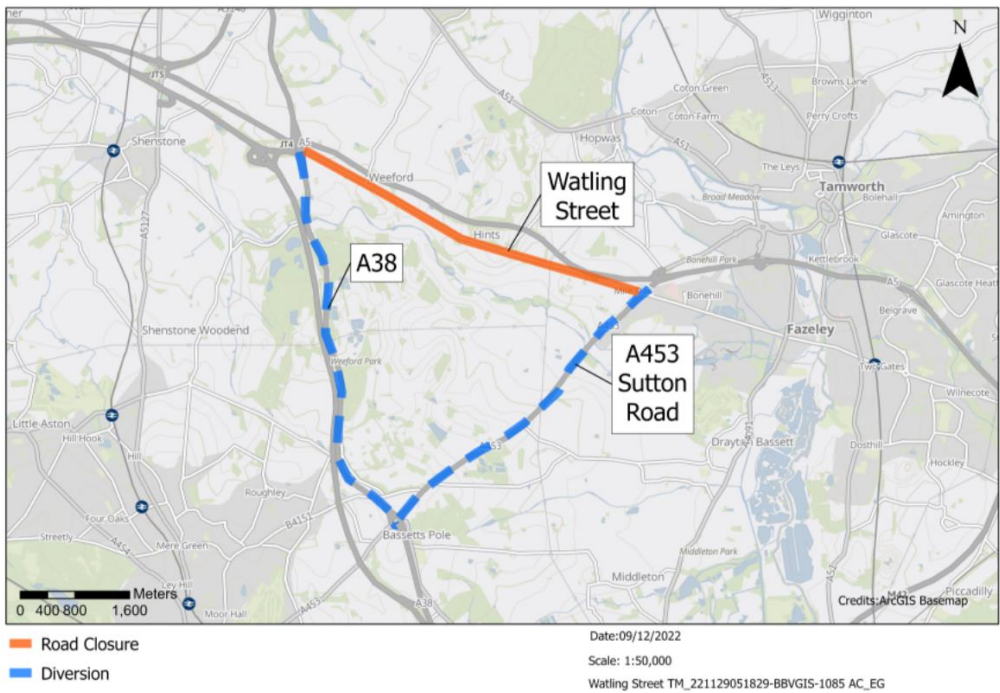
