Notice of Road Closure, Shipton Lee Road, Quainton

High Speed Two (HS2) is the new high speed railway for Britain. If you have any questions or enquiries about our work, please contact our Helpdesk to find out more. You can sign up for regular updates in your local area at www.hs2inyourarea.co.uk.

What are we doing?

In early April, we will be temporarily closing a section of Shipton Lee Road while we continue working on utility connections in the area.

We will be carrying out ground investigation surveys to identify the locations of underground utilities as well as determining ground composition and condition.

Shipton Lee Road will be closed at the junction with North Farm Lane 24-hours a day with a signed diversion route. This closure is necessary for reasons of safety as our teams will be working on and around the carriageway.

When will these works take place?

A section of Shipton Lee Road will be closed, 24-hours a day, from Tuesday 11 April until Friday 21 April 2023. Access for emergency services and farm traffic will be maintained.

These dates may be subject to change due to circumstances outside of our control, such as weather. Please refer to the HS2 website regularly to check for any changes or updates.

Duration of works

A section of Shipton Lee Road will be closed 24-hours a day from Tuesday 11 April until Friday 21 April 2023.

These works will be carried out within our normal working hours between 8am and 6pm. However, additional evening or weekend working may be required.

What to expect

Full road closure of a section of Shipton Lee Road for ten days.

Surveys for utilities and ground conditions.

Varied activities with both quiet and busier periods.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

Provide a full diversion route for road users.

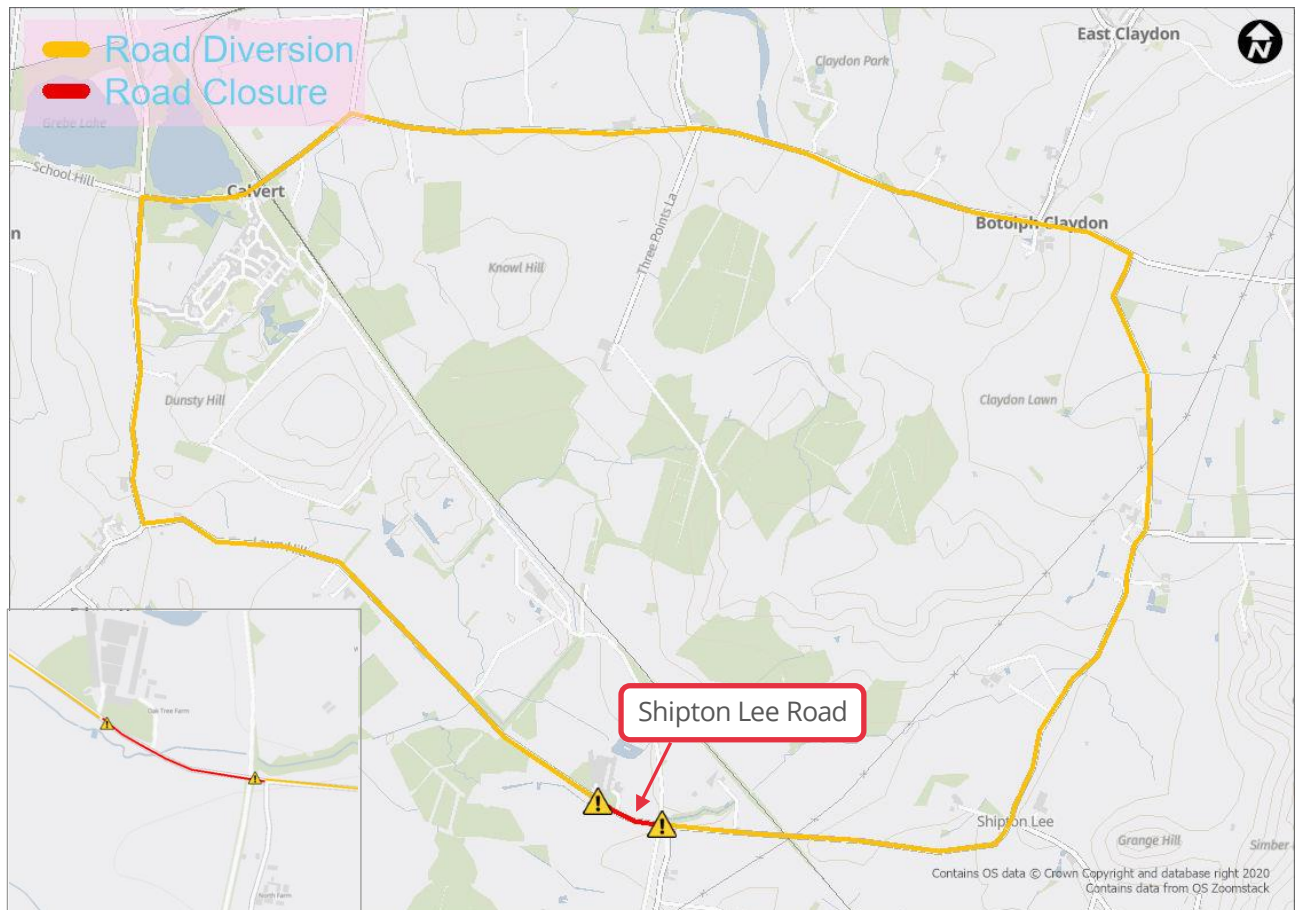
