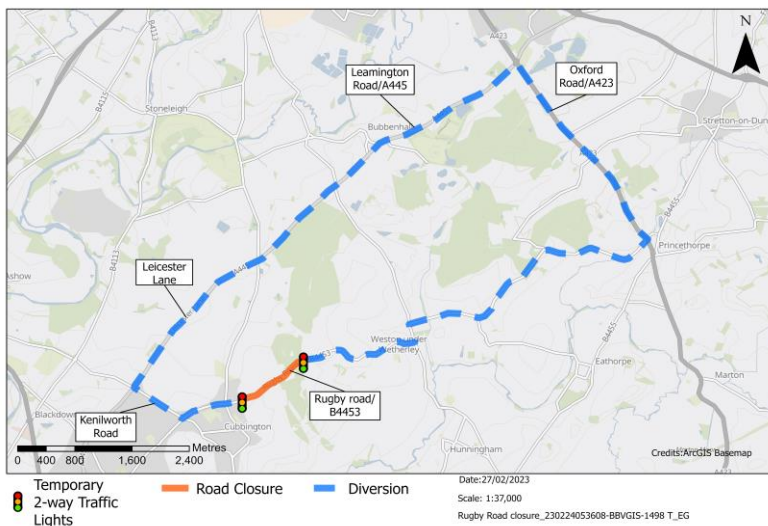
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

Due to the unforeseen circumstances we need to extend the service diversion works on Rugby Road. We will be testing and reconnecting the diverted utilities, removing telegraph poles and overhead cables.

Amendment – date extension to 20 May 2023

Following an unforeseen event in the Cubbington area and police instruction, we were unable to complete works on Rugby Road today. The road closure has been removed; we will install temporary two-way traffic lights. These will remain in place until we complete works.
