High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be completing

As part of our continued utility works in the area, we will complete utility diversions along sections of Watton Lane and Gilson Road. To do this work safely, we will install traffic management along sections of both these roads. The traffic management will be in place from Monday 3 April until Sunday 16 April.

This work will be undertaken through two phases of traffic management. Due to the excavation work that will take place, all the traffic management will be in place 24-hours a day with three-way traffic lights. To reduce disruption to the local roads, the traffic lights will be manually controlled between 7.00am and 7.00pm. The location and dates of the phases of the traffic management is shown on the map below and on page 2.

Phase 1 – Monday 3 April until Sunday 9 April



Duration of works

- Traffic management on Watton Lane and Gilson Road to take place from 3 April until 16 April

What to expect

- Both phases of traffic management to be 24-hour, three-way traffic lights and to be manually controlled between 7.00am and 7.00pm
- Our working hours are from 8.00am until 6.00pm on weekdays and 8.00am until 1.00pm on Saturdays
- Our workforce may be on site, one hour before or one hour after, to set up and take down equipment

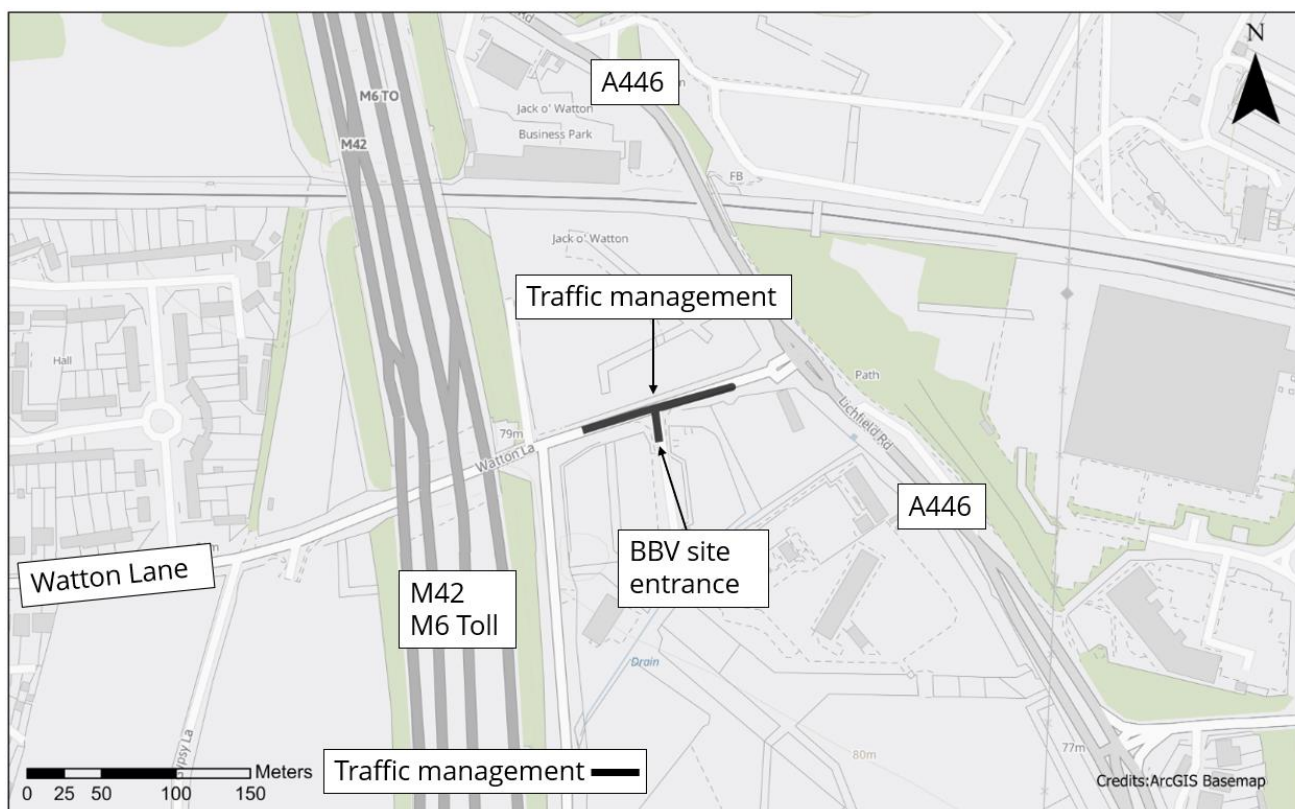

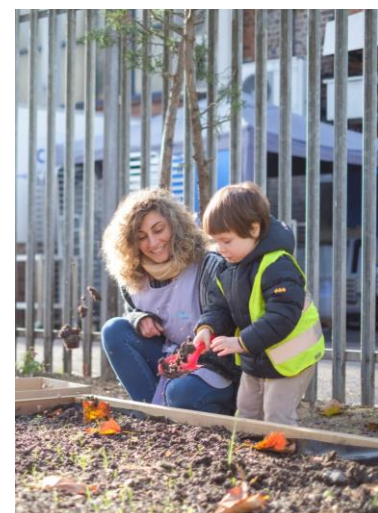
About our Community and Business Funds
