High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

To continue to prepare for our works to realign the existing Gilson Road, we will complete vegetation clearance works along a short section of Gilson Road. All necessary permits will be in place prior to works commencing and where necessary, ecological surveys will be conducted prior to and during the works.

Traffic management

In order to complete these works safely, we will install three-way traffic lights along Gilson Road. The traffic management will take place from Monday 3 April until Thursday 6 April from 9.30am until 3.30pm each day. To ensure safe access and egress from our site entrance on Gilson Road, we will install traffic lights within our site.
