Footpath closures on Park Village East north – March to April

High Speed Two (HS2) is the new high speed railway for Britain.

Footpath closure and parking bay suspensions opposite 26 to 28 Park Village East for planter maintenance – 31 March

We carry out regular maintenance to the planter on Park Village East. On 31 March, we will close the footway and temporarily suspend three parking bays opposite 26 to 28 Park Village East, to trim the overhanging trees and bushes. We are sorry for any inconvenience these works may cause.

Footpath closure and parking bay suspensions in front of 22 and 24 Park Village East for ground investigations – 17 to 28 April

We previously informed you we will carry out ground investigations within the footpath in front of 22 to 24 Park Village East. These works were planned to start in late March but have now been rescheduled and will start on 17 April. We expect these works will take about two weeks to complete.

We will close the footpath and suspend four parking bays in front of 22 and 24 Park Village East. We will maintain property access and divert pedestrians to the footpath on the other side of the road.

We will lift the paving stones and dig a trial hole within the footpath to determine the location of existing utility services. We may need to break through a small layer of concrete or hard layers of soil. Depending on the outcome of the trial hole, we will then use a machine with a large drill attachment to dig a borehole and assess the ground beneath.

You will notice periods of increased noise while we dig the borehole. We will use acoustic blankets to limit noise and dust.
