High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

In line with the design, we will be continuing with utility works adjustments around Rugby Road. Specifically testing and reconnection of diverted utilities, removing telegraph poles and overhead cables. To carry out the works safely will require a full closure of Rugby Road, which will be done in two phases.

When will these works be taking place?

Phase one: 11 to 14 April 2023 – Full closure of Rugby Road from 8am to 6pm, with overnight two-way temporary traffic lights in place.

Phase two: 24 April to 5 May 2023 - Full closure of Rugby Road 8am to 6pm, with overnight and weekend including bank holiday temporary two-way traffic lights in place.

Access to all homes and businesses will be maintained throughout. Our working hours will be from 8am to 6pm Monday to Friday.

Our workforce maybe on site one hour before and one hour after to set up and secure our equipment.

Phase one: 11 April to 14 April 2023

Full road closure 8am to 6pm, with overnight two-way temporary traffic lights in place

Phase two: 24 April to 5 May 2023

Full road closure 8am to 6pm with overnight two-way traffic lights

Weekends including bank holiday, two-way temporary traffic lights

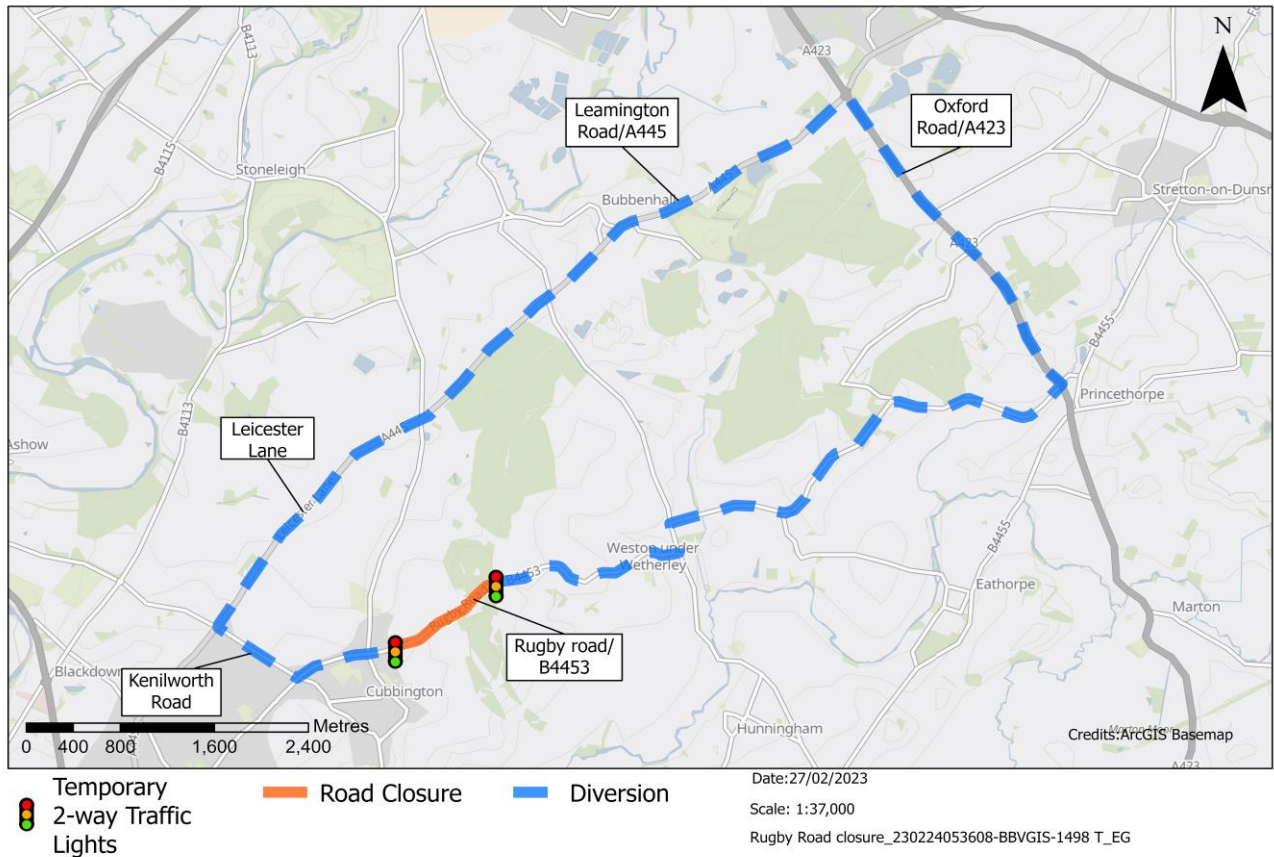

FAQ

Some of our frequently asked questions about works your area

Q: Why can't utility contractors do all their work on Rugby Road in one go to prevent disruption?

A: The HS2 Act committed to closing a road for a maximum of 28 days. Therefore, all our works need to be programmed to fit within that framework. Unfortunately, moving utilities can be difficult and there are specific regulations regarding the interaction between gas mains, electricity, telecommunications infrastructure, sewers and water mains. Due to the proximity of utilities to each other, it would be unsafe to attempt do more than one at a time.

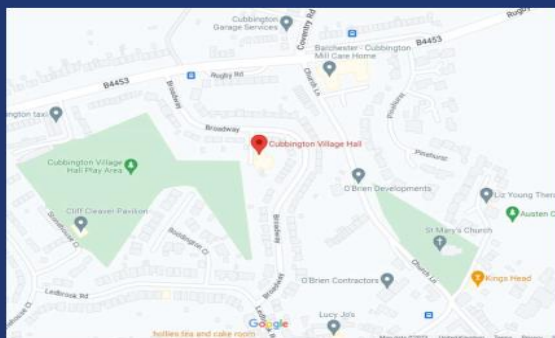
