What we are doing

We wrote to you on 23 February 2023 to let you know about our plans for the reinstatement of ground in Rabournmead Drive Park following the main sewer protection works. We planned to open all the park on 10 March. These works have been delayed due to the recent wet and cold weather. We will keep an area of the park closed until 31 March to allow for the reinstatement of this area and any reseeding of grass to be undertaken. If this area does improve we may be able to open this sooner.
