High Speed Two (HS2) is the new high speed railway for Britain. Working on behalf of HS2 Ltd, Balfour Beatty is carrying out surveys along the Phase 2a route.

What we are doing

HS2 Ltd is proposing to make changes to the M6 Hanchurch Interchange at Junction 15, Newcastle Road, Clayton Road and the junction of Newcastle, Trentham and Whitmore Road, to improve the traffic flows during the construction of HS2.

During the detailed design stage of the process, we have identified four areas where further utility surveys are required.

Due to the location of these surveys, and to enable us to complete them safely, we will need to install traffic management during the work. We have worked hard to reduce the impact. However, there will be two-night shifts required to complete the work.

Resident access will also remain uninterrupted throughout.

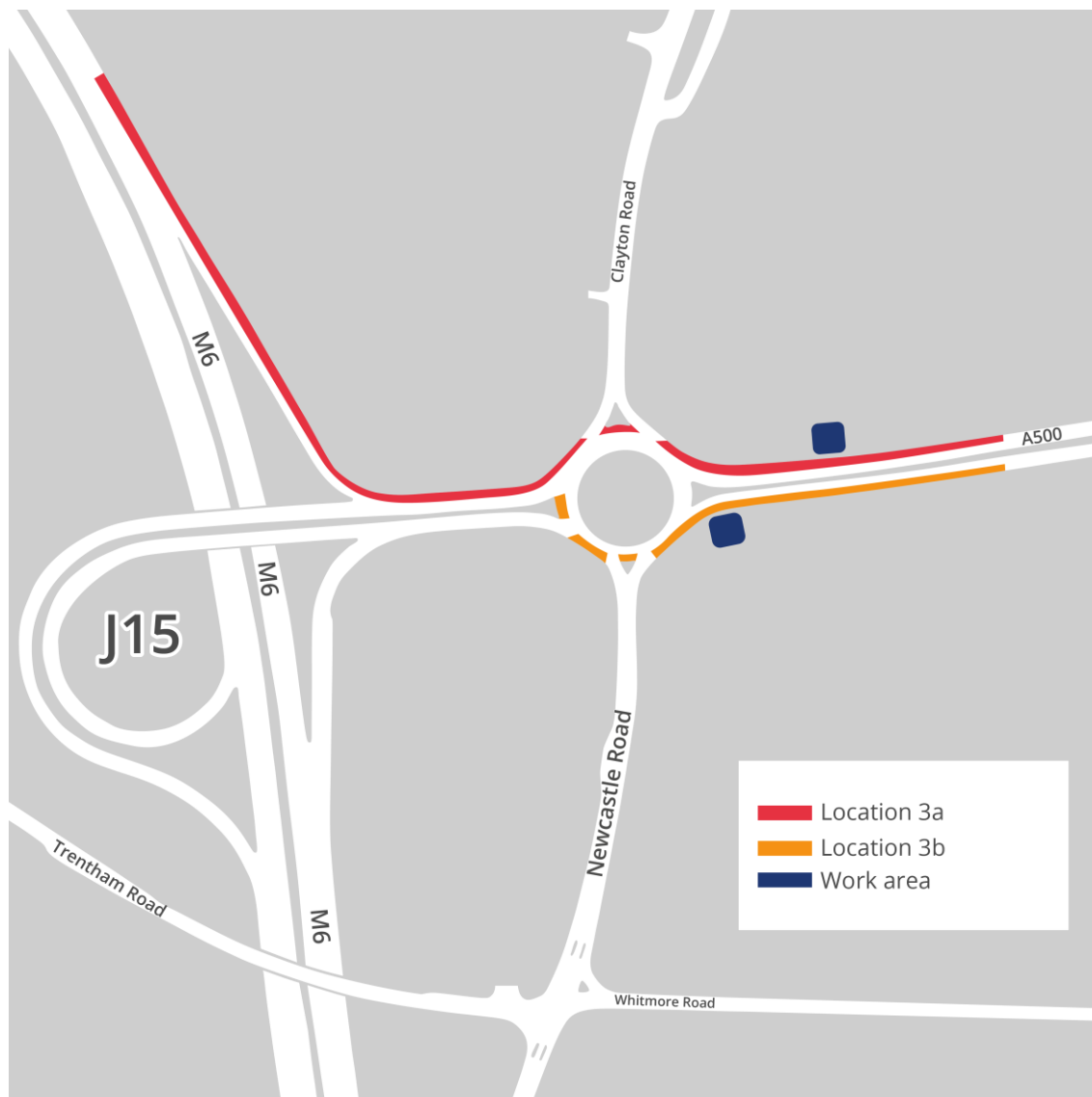
