
#### Wells House Road community meeting – 7 February 2023

# **You Said:** We would like the hoardings to be green or be more relevant to the local community

#### We have: We hosted an engagement event and received feedback from a few residents that they would like the blue painted hoardings to be changed to green.

#### We will:

We are aware of concerns about the brightness of hoarding lights. We are looking into this with the site team and will feedback in future meetings.



## **You Said:** We would like the Wells House Road stairs to open sooner than 2027

#### We did: We have brought forward the design and construction of the stairs stabilisation works by 4 years.

#### We will: Engage with you regarding the final look and feel of the stairs. We currently expect engagement to start in May 2023.



#### You Said: The site lights are shining into properties

#### We have: We have looked into this with the site team and have fitted timers to the car park lighting.

#### We have:

The lights have been adjusted following further feedback and now turn off at 9pm every evening and come on at 5:45am in the morning.

#### **We will:** As daylight hours are increasing, we will continue to monitor the lighting requirement

on site.

# You Said: Improve traffic flow and light sequencing along Old Oak Common

We did: Old Oak Common Lane and Atlas Road light signals have been adjusted and this trial is ongoing.

We did: CCTV has been introduced on the traffic lights to monitor levels of traffic. The lights can be adjusted accordingly.

#### We did: A speed sign has been installed to encourage slower speeds going down Old Oak Common Lane.



### You Said: Improve the conditions along Old Oak Common Lane

We did: HS2 continue to monitor Old Oak Common Lane and work with stakeholders to maintain conditions.

On 19 January, London Borough of Ealing carried out emergency temporary repairs to the potholes along Old Oak Common Lane.

In late January, London Borough of Ealing carried out repairs to the pavement close to the North London Lines.



### You Said: 'Keep clear' markings outside Wells House Road

We will: Request for additional markings outside Wells House Road is with London Borough of Ealing.



#### You Said: Residents are concerned about cracks to their properties

#### We will:

Residents who are concerned need to contact Helpdesk with photos of the cracks. A small claim form will then be sent to you either by email or post.

We will: Support you with completing the forms. Those who have completed their forms are going through the claims process with the loss adjuster.


# Old Oak Common Station Site Updates

Wells House Road community meeting – 7 February 2023

### **HS2 Station Box**




- Excavations and concrete works are ongoing.
- This work is moving east and below ground, noise and other impacts should be reducing.




### **Conventional Station Works**



- Piling is ongoing for the above ground station and 8 new platforms.
- Some works near the railway will involve night shift working, starting in mid-February until end of April.



### **BBVS Conveyor**



- Operational from October 2022.
- Takes excavated materials from HS2 Station Box to the Willesden Euroterminal site.
- As of 20 January 2022, circa 12,000 lorry movements worth of material



### Wormwood Scrubs Works Update

- The section furthest east of the SBS site is 100% completed.
- We have removed the hoarding and replaced it with Heras fencing.



### **OOCL retaining wall and utility work**



- Piling works are ongoing.
- Lane closure in place along Old Oak Common Lane **(OOCL)**, which will be shifted south for future utility works.
- Multiple traffic light signals and traffic in peak times.




### **Old Oak Common Lane Rail Bridges**

Works that are ongoing until end of February 2023 includes:

- Surveys
- Excavation
- Setting out piling mats
- Vegetation clearance

During March 2023, we have piling work required for the construction of the new bridge.

Work will need to be carried out under a single lane closure to ensure public safety.


### Wycombe Single Line Bridge

Update on removal of Wycombe Single Line Bridge

- The is currently expected to take place during May 2023
- The work will be carried out under full road and footway closure to ensure public safety

Impacts

- A full road closure will be in place for 7 days
- Highway diversion routes in place
- Some footpath closures required





# SCSJV future tunnelling works – planned engagement

Wells House Road community meeting – 7 February 2023

#### Tunnelling works in Old Oak and Park Royal

SCSJV are working in the Old Oak and Park Royal area in partnership with HS2 and alongside BBVS (Balfour Beatty VINCI SYSTRA), who are building Old Oak Common Station.






#### Tunnelling works in Old Oak and Park Royal

During Spring 2023, Skanska Costain STRABAG Joint Venture (SCSJV) will be launching its TBM to construct the logistic tunnel from the Atlas Road site to the Old Oak Common Station site.

Once launched, the TBM will take approximately six months to tunnel the 853 meter route.

The logistics trunnel will have two main purposes in supporting the construction of the HS2 tunnels between Old Oak Common and Euston:

- to transport the tunnel segments from the Atlas Road site to the works to build the Euston Tunnels. The segments will be transport by a multi service vehicle and there will be measures in place, such as reduced speed limits where vehicles pass nearby residential properties to minimise disruption while the tunnel is in use.
- to move excavated material from the Euston Tunnels by a conveyor system to the Willesden Euroterminal site, where it will be removed by rail.

Euston Tunnel	Construction of the Euston Tunnels is planned from winter 2023/24 to summer 2025*.			
Northolt Tunnel East	Construction of the Northolt Tunnels East towards Greenford is planned from summer 2023 to summer 2024*.			
Old Oak Common Tunnel	Construction of the Old Oak Common Tunnels is planned from late 2023 to late 2025*.			
Atlas Road Logistics Tunnel	Construction of the logistics tunnel is planned from spring 2023 to autumn 2023*.
