



Emergency notice of lane closure on A452 bridge over M42

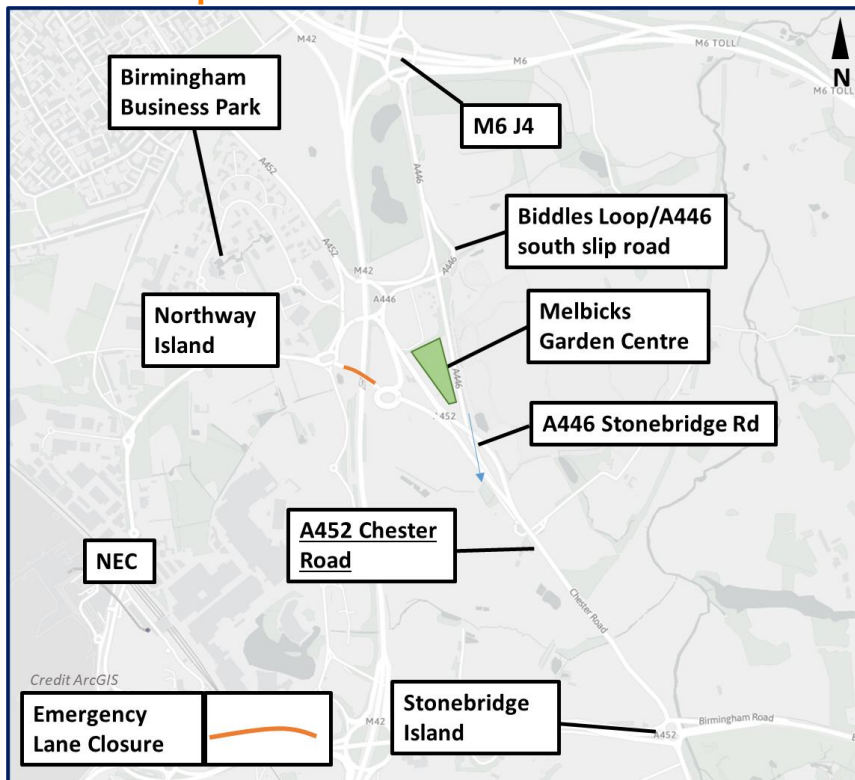

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

The work we will be doing

A recent safety inspection has highlighted a potential concern on the A452 bridge over the M42. To make it safe while we carry out an investigation and any remedial work, we will need to close one lane of this bridge from 27 April 2023 until it is resolved. If this work is likely to take more than two weeks, we will send you a further update.
