High Speed Two (HS2) is the new high speed railway for Britain. If you have any questions about this, please contact our Helpdesk to find out more. You can sign up for regular updates in your local area at www.hs2inyourarea.co.uk.

What are we doing?

In order to enable the construction of HS2, we have to temporarily close and divert sections of Public Rights of Way (PRoW) near Brackley and Turweston.

As part of our continued work in the area, it is now necessary to temporarily close sections of BD10 and BD7. These closures are required so that we may begin our main construction for the temporary diversion of the A43 and the A43 Overbridge.

Temporarily diverting the A43 will allow our teams to construct the A43 Overbridge. This overbridge will allow traffic to travel over the HS2 railway line. The temporary diversion of the A43 is expected to be completed by late 2023 and the A43 Overbridge is expected to be completed in late 2025.

Signage on the PRoWs will indicate the closure areas. After the railway line has been constructed, these PRoWs will be reinstated.

When will these works take place?

Sections of the PRoWs known as BD10 and BD7 will be closed, 24 hours a day, and will remain closed for approximately two years.

Duration of works

Sections of the PRoWs known as BD7 and BD10 will be closed from the end of April 2023.

What to expect

Temporary bridleway closures for approximately two years.

Noise from plant and equipment used to construct the temporary diversion of the A43 and A43 Overbridge.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

Take care to respect the community.


