

# Notice of a lane closure on the A34 leading onto Aston by Stone roundabout

High Speed Two (HS2) is the new high speed railway for Britain. Kier is carrying out surveys and investigating ground conditions along the Phase 2a route.

## What we are doing

We are continuing to develop designs for junction improvement to support traffic flow. For reasons beyond our control, we need to return and carry out a small section of ground investigation we were unable to complete in December 2022. This will provide us with samples and allow us to view the structure and record the layout of land.

To carry out this work safely we will need to close lane one on the northbound carriageway leading onto the Aston by Stone roundabout, Stone.

## When the work will take place

From Wednesday **3 May to Friday 5 May 2023** between the hours of **9pm and 5am**. We will work during the night with the location differing on each night as we move along the road. Please note that all our planned roadworks may be subject to change due to weather conditions or unforeseen circumstances.

## How will this affect you

To complete the work safely, temporary traffic lights will be put in place for us to carry out our surveys. We recognise that this can be frustrating, but this is the safest and least disruptive way of completing our survey work. As part of the work, we will use machinery and equipment that may generate some noise throughout our time on site, but we will work to reduce the impact on residents.

## How we will minimise disruption

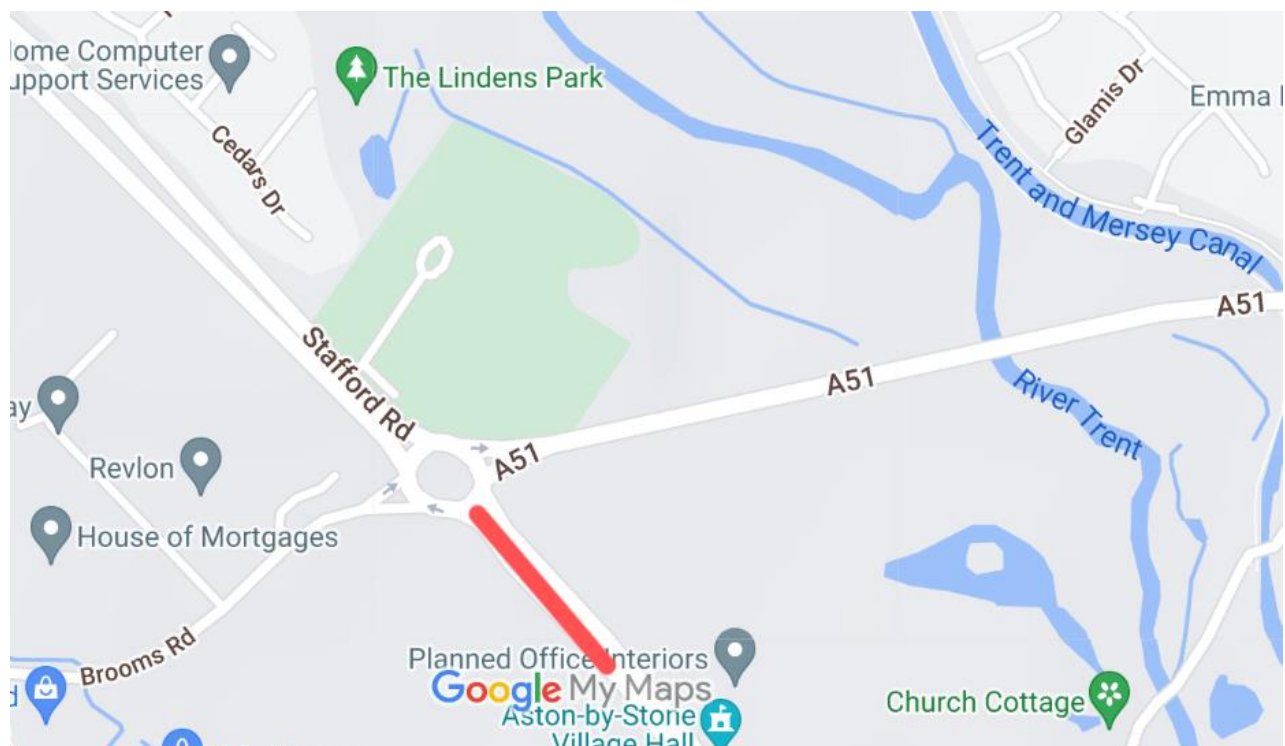
We will work hard to minimise the impact of these works. We will maintain access for properties within the traffic management.

We will also carry out the following:

Switch off vehicle's engines when not in use.

- Obtain permission from the County Council to avoid clashes with other roadworks in the area to prevent delays.
- Restore work areas to their original condition and work hard to complete the work safely and as quickly as possible.
