

HS2 Event Recording Notice - Terms

The event you are attending will be recorded with photography and/or video.

There may be flash photography.

The following terms apply to the capturing and use of the content recorded.

Purposes

Photographs and videos recorded ('Content') may be used by or on behalf of High Speed Two (HS2) Limited (**HS2**) and its partner organisations described below for the current and future activities of HS2, which includes reproduction and use of some or all of the Content or adaptations of it in printed or digital media formats:

- for promotional and publicity purposes including printed publications, websites*, social media, multimedia products, film, presentations and in press releases;
- in branding and information material such as outdoor media, posters, banners or displays;
- for educational and archiving purposes including in teaching and research materials and in material recording the progress of the HS2 project;
- for reporting purposes including in reports for publication in accordance with HS2's obligations as a public body.

*Images on websites can be seen worldwide and not just in the UK where UK law applies. Some countries may not provide the same level of protection to the rights of individuals as EU/UK legislation provides.

HS2's **partner organisations** means entities that HS2 works with in connection with the HS2 project and the Purposes, including its stakeholders, contractors and suppliers, media agencies, educational establishments, community and other bodies.

Personal Data

Personal data may be processed in conjunction with the use of Content described above, for example where name badges are worn by attendees and are visible in Content, or where awards are presented to individuals and Content is captured to record this. Your rights in connection with the processing of personal data are set out below.

Storage

Content will be stored securely, and for so long as is necessary to fulfil the Purposes. Once incorporated some Content may be permanently retained in publications as an archive of the HS2 project.

You agree

- that HS2 retains copyright in the Content and all moral rights are waived;
- that no fee is payable in respect of any use of the Content;
- that HS2 has full rights to edit, modify, crop, add to or subtract from the Content as it considers appropriate, and that you release HS2 and the partner organisations from all claims and demands arising out of the use of the Content; and
- to not engage with any third party (including the media) in connection with Content.

Your rights

HS2 processes personal data in accordance with the data protection law including the Data Protection Act 2018. English law governs the terms of this consent form.

You can withdraw your consent at any time by emailing HS2DataProtection@hs2.org.uk with your name, an image of you so that we can identify you, and any other details you think may assist in locating the Content (e.g. details of the event where the Content was recorded). The Content will not be used in future publications but may continue to appear in publications already in circulation.
