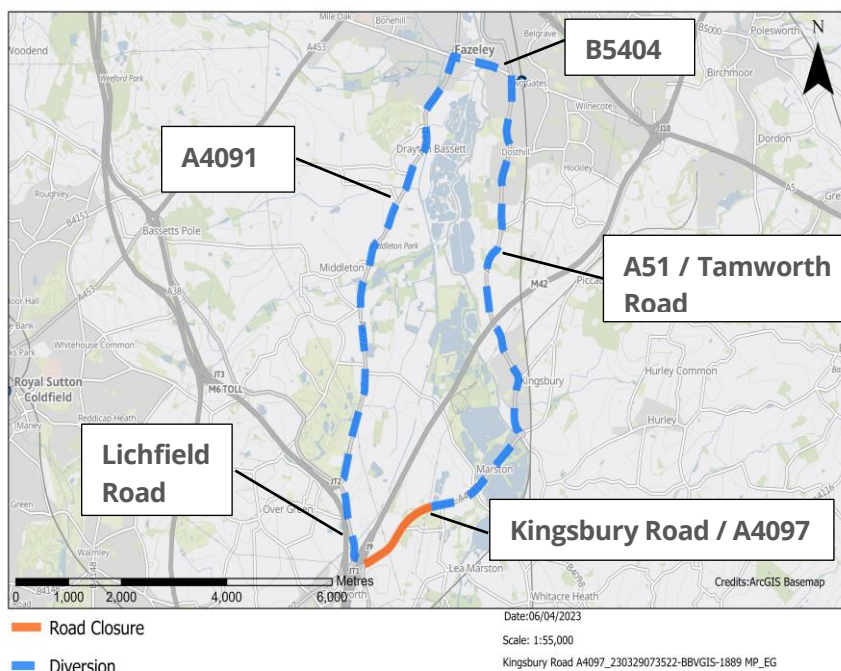
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To enable the construction of the new railway we will need to divert utilities located on the A4097 Kingsbury Road. Prior to commencing these diversion works we need to undertake surveys along the A4097 Kingsbury Road which will require temporary overnight closures. A signed diversion route will be in place (see map on page2).

When the work will take place

We will complete these works overnight between Monday 8 May to Friday 12 May 2023. Our working hours will be 9pm to 5am.
