



## Notice of traffic management on Wood End Lane, Fradley

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we will be doing

We will be working along Wood End Lane to create a safe access to our working area. As part of these works we will also clear a small section of vegetation and undertake trial hole surveys. To undertake these works safely we will install temporary traffic lights on Wood End Lane.

### When the work will take place

We will install temporary traffic lights from Tuesday 2 May to Friday 19 May 2023. The traffic lights will be in place weekdays (Monday to Friday) and our working hours will 8am to 5pm.

For us to complete this work safely the traffic lights will operate 24 hours, for three days, during this period.

Our workforce may be on-site up one hour before and after to set up and secure our equipment.

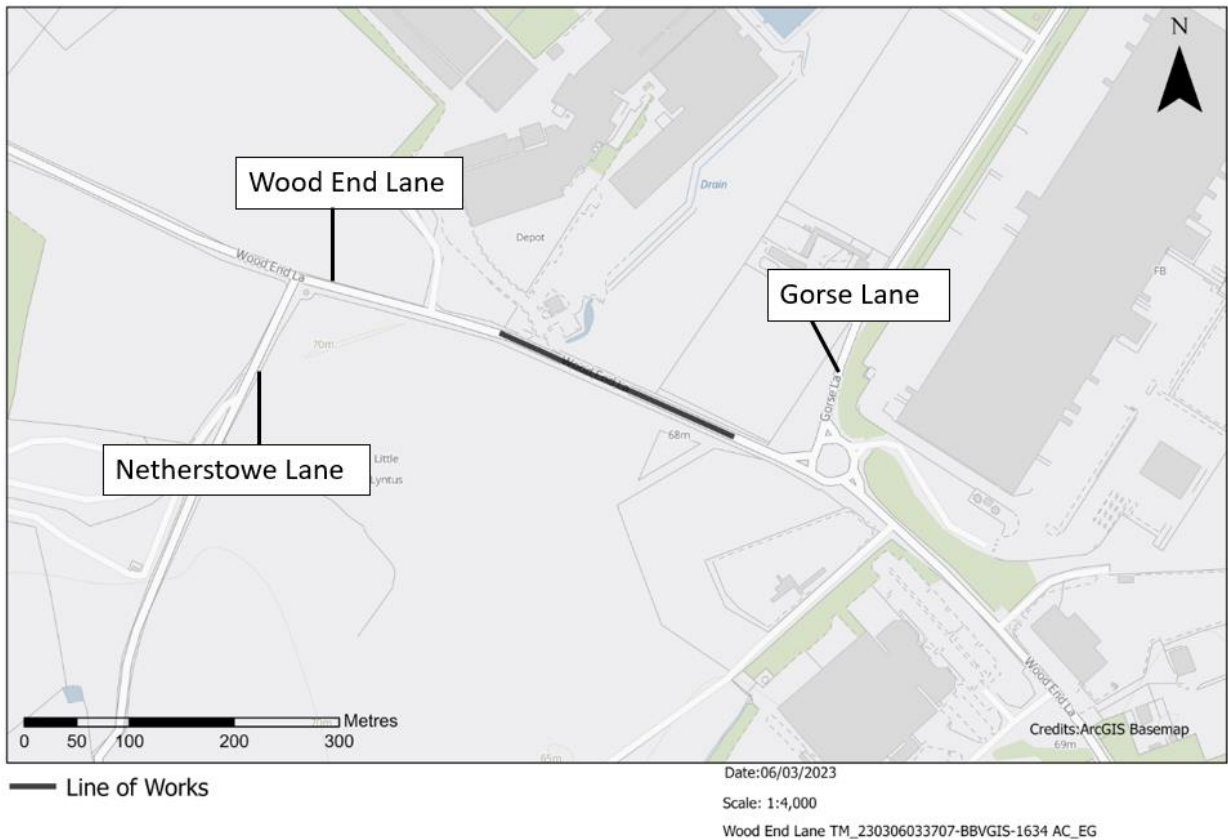
