# Notice of works to the East of Euston Station

High Speed Two (HS2) is the new high speed railway for Britain.

Mace Dragados is the Construction Partner building the new HS2 station in Euston.

We will not proceed to the full construction of Euston station in the next two years. We will use this time to look again at the Euston station design to ensure that it is affordable and delivers for the local community and passengers.

Whilst most work on the station site will stop, some critical activities will continue.

Vodafone utility diversion works on Lidlington Place and Harrington Square from late April until late May 2023

# What are we doing?

We are undertaking Vodafone utility diversion works in Lidlington Place and Harrington Square.

We will start laying ducting in Lidlington Place (south) towards Harrington Square, we will then cross over to Harrington Square (north) to continue towards Hampstead Road. This will reduce the need to have traffic signals and keep both roads open to traffic.

6 parking bays in Lidlington Place will need to be suspended.

Harrington Square will require two lanes to be closed from the junction of Harrington Square and Lidington Place towards Hampstead Road, one lane will remain open all times for vehicles to turn onto Hamstead Road

Pedestrian access will remain with diversions in place.

# When will these works take place?

From late April to late May.


