High Speed Two (HS2) is the new high speed railway for Britain. If you have any questions or enquiries about our work, please contact our Helpdesk to find out more. You can sign up for regular updates in your local area at www.hs2inyourarea.co.uk.

What are we doing?

In May 2023, we will be temporarily closing a section of the footway along Station Road while we make preparations to join it to the new Station Road realignment. These works will include the careful removal of some vegetation where the junction between the two roads will be built.

Prior to any vegetation removal, an ecologist will complete a detailed survey of the area to be cleared. Any protected species found to be present will be recorded and the vegetation will be left undisturbed with the appropriate buffer zone established. Vegetation clearance will only commence once further surveys and mitigation can be established to confirm that the protected species are no longer present.

This closure is necessary for safety reasons as our teams will be working on the footway.

When will these works take place?

A section of footway along Station Road will be closed from Monday 15 May until Friday 19 May 2023.

This section of Station Road will remain open to road traffic during these works.

These dates may be subject to change due to circumstances outside of our control, such as weather. Please refer to the HS2 website regularly to check for any changes or updates.

Duration of works

The footway will be closed from Monday 15 May until Friday 19 May 2023.

Works will be carried out within normal working hours, however some additional evening or weekend working may be required when necessary.

What to expect

Limited 24-hour closure of the **footway only** along Station Road.

Varied activities with both quiet and busier periods.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

Provide a full diversion route for road users.
