
UPDATE

We previously notified you that Biddles Loop would be closed overnight on 26 April. This work will now take place over night on 2 May.

The work we will be doing

On 2 May for one night only, the slip road connecting the southbound carriageway of the A446 to Northway Island (known as Biddles Loop) will be closed to traffic so that we can install temporary safety barriers. Traffic will be directed down to Stonebridge Island at the A45 then back up to Northway Island via the A452 Chester Road. **Please see the Map below**

This slip road will be reduced from two lanes to one lane from 2 May until 6 August 2023.

Duration of works

Overnight closure on 2 May 2023 from 9pm until 5am the following morning.

Lane closure on southbound slip from 2 May until 6 August 2023.

What to expect

Low level noise from our work.

Our work force maybe on site one hour before and one hour after the closure.

Fully signed diversion.

Delay to journey times following diversion - Allow five minutes.
