



Notice of overnight closure of A446 southbound slip road (Biddles Loop) and lane closure.

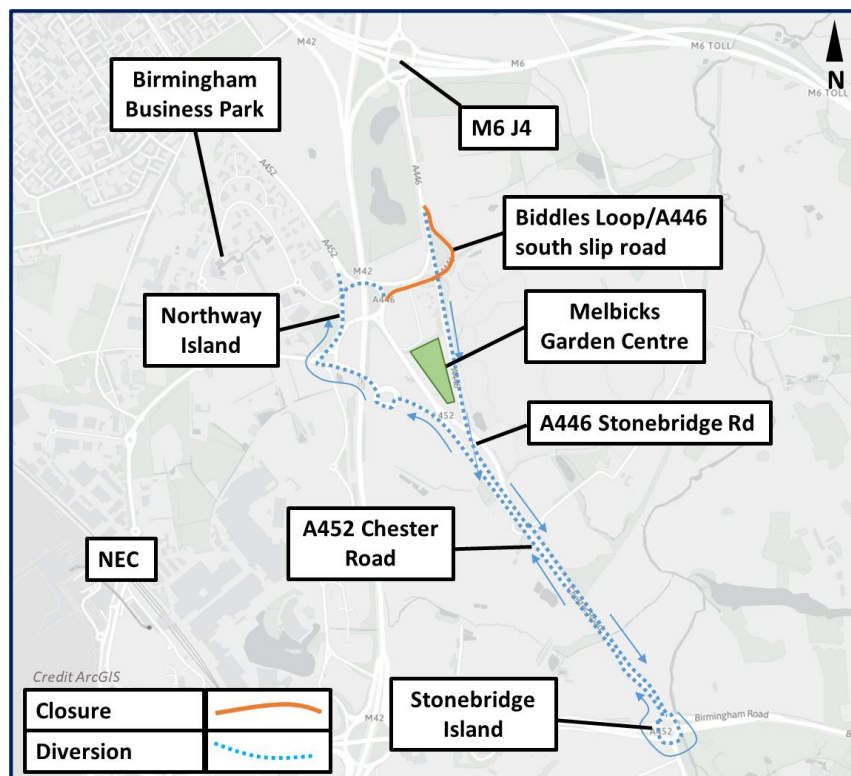

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

On 26 April for one night only, the slip road connecting the southbound carriageway of the A446 to Northway Island (known as Biddles Loop) will be closed to traffic so that we can install temporary safety barriers. Traffic will be directed down to Stonebridge Island at the A45 then back up to Northway Island via the A452 Chester Road. **Please see the Map below.**

This slip road will be reduced from two lanes to one lane from 24 April until 6 August 2023.

Over night closure on 26 April 2023 from 9pm until 5am the following morning

Lane closure on southbound slip from 24 April until 6 August 2023

Delay to journey times following diversion - Allow five minutes.
