High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

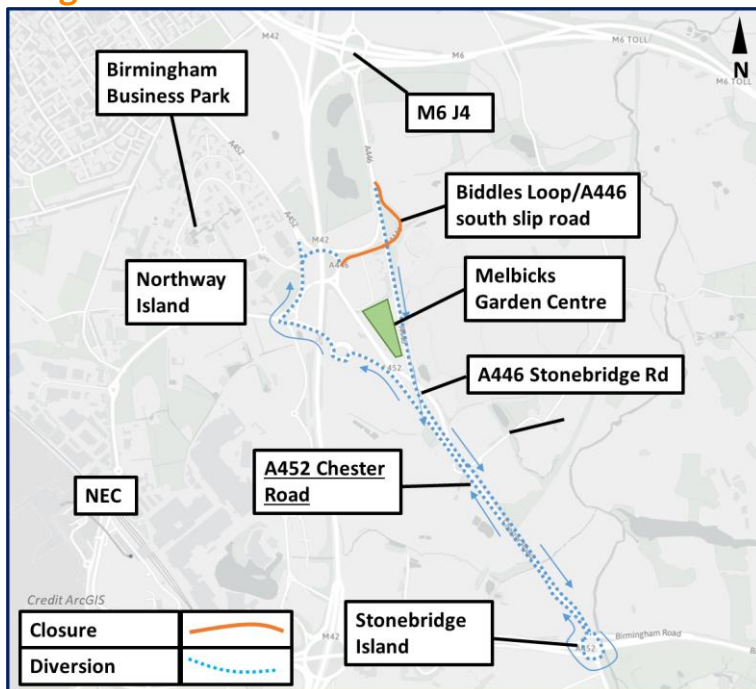
The work we will be doing

On 2 May for one night, the slip roads connecting the A446 Stone bridge road to Northway Island (known as Biddles Loop) will be closed to traffic so that we can install temporary safety barriers. Traffic will be directed down to Stonebridge Island at the A45 then back up to Northway Island via the A452 Chester Road. **Please see the Map below.**

The entrance and exit slip roads joining Northway Island to the A446 will be reduced from two lanes to one lane from 25 April until 8 June 2023. Traffic management will be placed on Northway Island to filter traffic into the correct lanes to avoid any confusion with the permanent road markings while this work is taking place. **Please see overleaf for more detail.**

Please note that the A452 is now on its permanent alignment over the roundabout the old alignment (south bridge) is now decommissioned.

Overnight Closure and Diversion



Duration of works

Overnight closure on 2 May 2023 from 9pm until 5am the following morning.

Lane one closure in both directions from 25 April until 8 June 2023.

Traffic management on the western side of Northway Island

What to expect

Low level noise from our work.

Our work force maybe on site one hour before and one hour after the closure.

Fully signed diversion.

Delay to journey times following diversion - Allow five minutes.

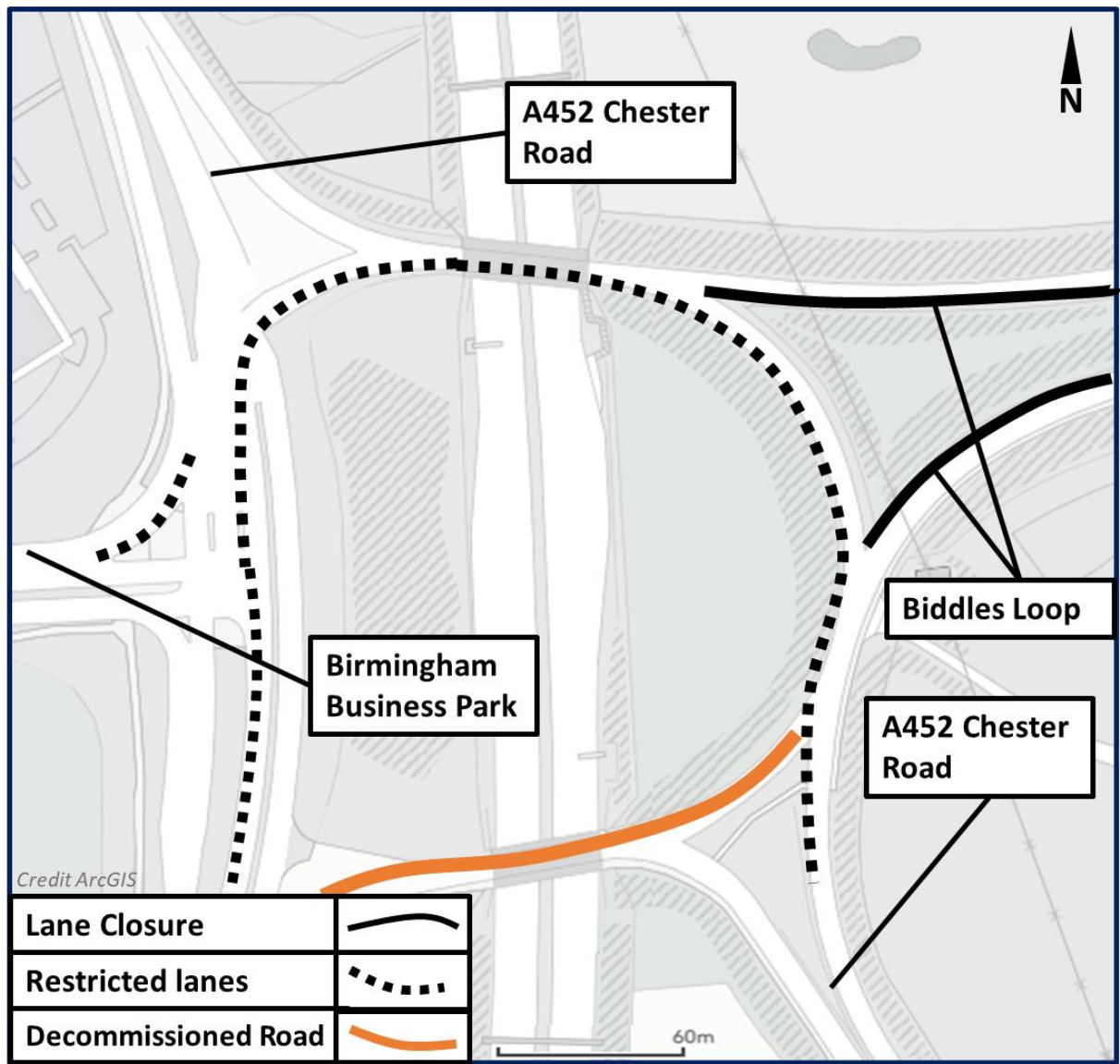

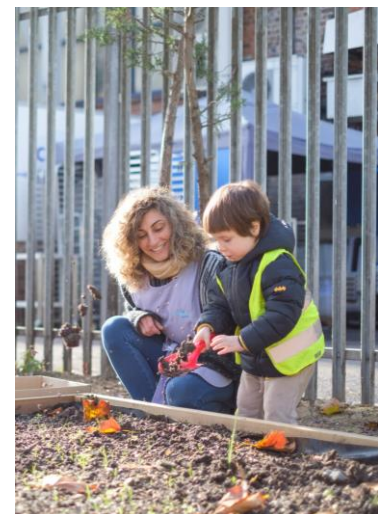
About our Community and Business Funds
