



UPDATE - Notice of road closure – Lavender Hall Lane – Berkswell

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

UPDATE

We previously notified you that Lavender Hall Lane would close on 30 May and reopen on the 30 June. To avoid our work clashing with other road works in the area, this work has been delayed and will now close from 26 June 2023 until 21 July 2023.

The work we will be doing

The new railway will pass under a new bridge on Lavender Hall Lane, before construction commences there are a number of important utilities that need to be diverted so that our works do not affect the supply to nearby communities. In order for us to do this safely we will need to close Lavender Hall Lane for a period of four weeks. There will be a fully signed diversion via Meriden and access for residents within the closure will be maintained. Please note that for safety reasons when Lavender Hall Lane is closed Solihull MBC require us to also close Baulk Lane, again access for residents within the closure will be maintained.

When will the work take place

The road will close on 26 June and reopen on the 21 July. The road will be closed 24 hours a day seven days a week although we will only work during our normal working hours which are 8am-6pm Monday to Friday, 8am until 1pm on Saturdays and not at all on Sundays and Bank holidays.

The works will be in place 24 hours a day seven days a week from 26 June until 21 July.

Longer journey time following the diversion - Allow 10 Minutes.

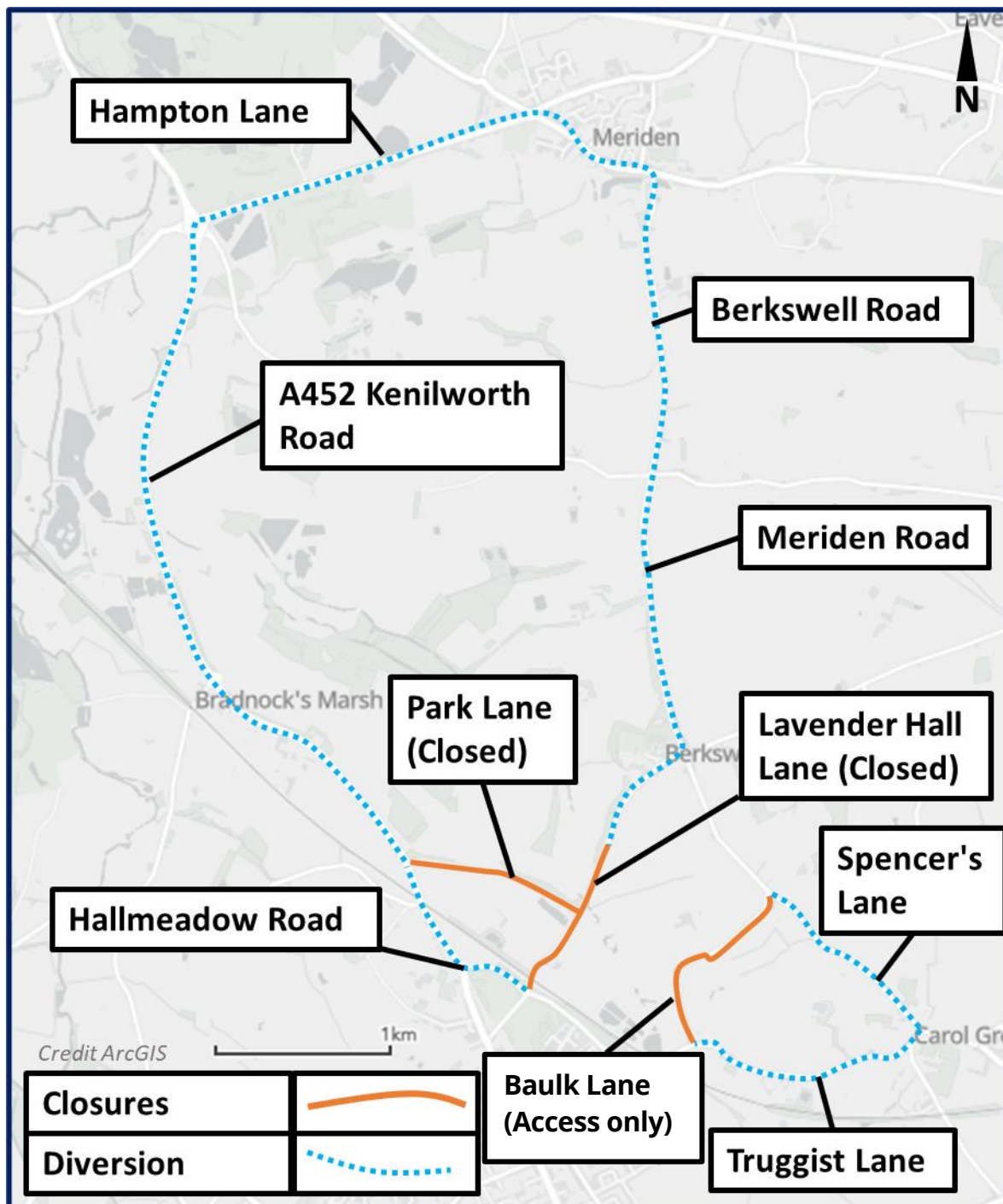
