



Update: Notice of temporary 15-minute closures at Casey Lane, Weston

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty and its appointed subcontractors are working on behalf of HS2 Ltd to carry out early environmental works between Lichfield and Crewe.

What we are doing

As part of our early environmental works, we are establishing critical environmental and species relocation sites creating new habitats for local wildlife before any main work starts.

We have been creating various ecological habitats on land off Casey Lane. Once complete, the habitats will be ready to receive sensitive species such as Great Crested Newts from other sites.

We are nearing the completion of work on this worksite, and now need to remove the temporary trackway installed in order to carry out the works.

To ensure the safe movement of vehicles required to remove trackway from the site, we need to temporarily close a small section of Casey Lane for 15-minute periods over a number of days.

When the work will take place

We will put the temporary closures in place on **from Monday 22 May to Friday 26 May 2023**, they will only be in place for 15 minutes at some point during the day. We will carry out all the other work during the day from 9am to 5pm,

Temporary 15-minute closures of a small section of Casey Lane Monday 22 May to Friday 26 May 9am-5pm.

(excluding weekends and Bank Holidays)

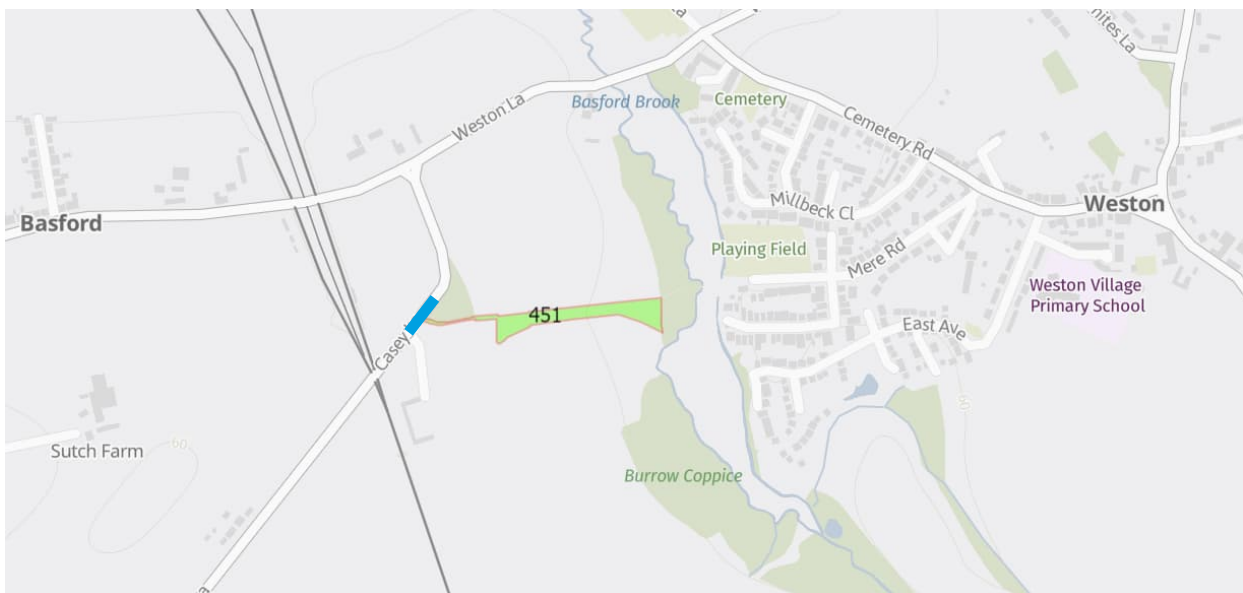

What to expect

The equipment we use may generate some low-level noise, we will be switching off engines when not in use and working during the day to minimise disruption to local residents. We will use the current farm access to bring the machinery onto the land.

Journeys may take longer than usual while the short-term closures are in place. The temporary 15-minute closures will be located on a small section of Casey Lane, shown in blue below.

About our Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
