

Update: Works on Park Village East

High Speed Two (HS2) is the new high speed railway for Britain.

In line with direction from the Government, we are pausing some work between Euston and Old Oak Common. This work includes the lay-by extension, new welfare building and second lorry lay-by.

Park Village East closure for lay-by works postponed

We previously informed you we would close Park Village East from 10 April to the end of May to

- extend the hoarding around the existing lorry lay-by at the northern end of Park Village East
- create an access within the hoarding to a new welfare building
- install a second hoarded lay-by at the southern end of Park Village East.

The lay-by extension, new welfare building and second lorry lay-by will be put on hold so the road closure is not required now. The existing lorry lay-by will revert to its original layout and remain operational. We are continuing the design of the welfare building and will update you when we have more information.

Mornington Street bridge closure remains in place

Mornington Street bridge will remain closed to vehicles whilst monitoring and works beneath the bridge continue. It remains open to pedestrians and cyclists, with the Park Village East one-way system in place.

Maintenance to planter on Park Village East postponed

We planned to close the footpath and suspend three parking bays at the northern end of Park Village East to trim the overhanging trees and bushes in the planter. We have delayed these maintenance works until after Easter.
