Overnight works planned on Regent's Park Road


Overnight on 26 May 2023 we will be carrying out a ground survey on Regents Park Road Bridge.

The surveys will help us to understand the best ways to protect or divert utilities services during construction, and assist the design of the new railway.

How this might affect you

To ensure the safety of the public and our staff, temporary traffic changes will be in place which will include, closing the cycle lane and narrowing the pedestrian footpath.

We will be working as efficiently as possible whilst keeping our work areas safe and tidy. You can view a map showing the location of these works below.
