High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will do


To enable the construction of the new railway we will need to undertake utility surveys to assess the location of buried services, prior to undertaking any required diversion works. To ensure the safety of the public and our workforce we will install overnight closures of the A4091 northbound carriageway. The A4091 southbound carriageway will not be affected during these closures.

When the work will take place

The overnight closure will be in place between 12 June and 16 June 2023 from 9pm to 5am each night.
