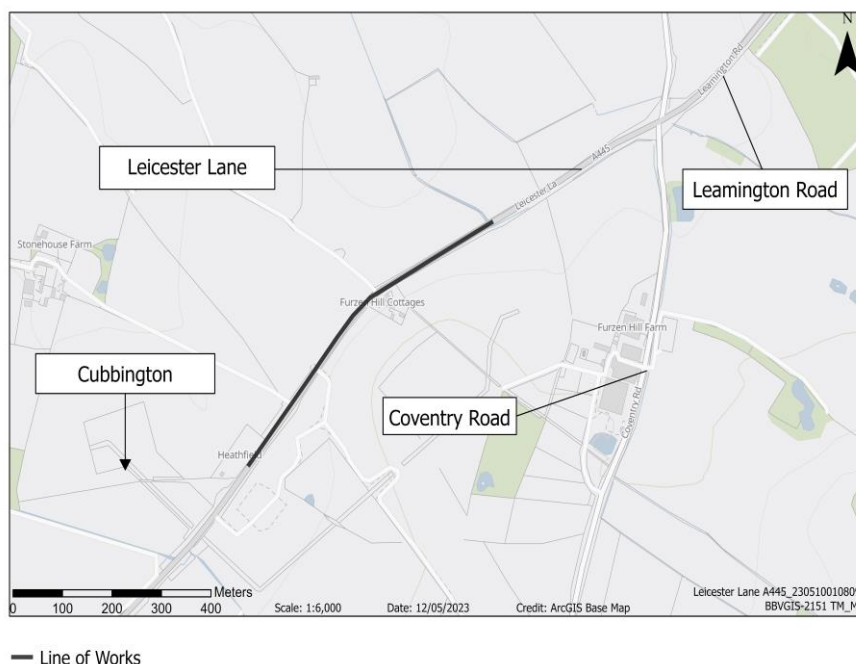

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We will be completing the new signage in the highway. Due the limited amount of space on the verge in this area and to ensure a safe working environment, we need to put in place two-way temporary traffic lights.

The temporary traffic lights will be on 31 May 2023 between 9.30am and 3.30pm. They will be operating during off peak hours to reduce disruption to local road users. The road will be re-opened by 3.30pm.
