High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing.

As part of the utility diversion works, we need an additional road closure to install a new sewer which requires significant machinery and a deep excavation in the highway.

To carry out the work, we need to close the road to create a safe working environment. A fully signposted diversion will be in place, with access for pedestrians, cyclists, homes and businesses throughout.

When will these works be taking place?

12 June 2023 to 24 June 2023 Cromwell Lane will be closed from 9am to 3pm.

Cromwell Lane will be closed on: 12 June to 24 June between 9am and 3pm 2023
