High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Installation of new site access gate

We previously notified you that as we prepare to start working on the section of site closest to Lawley Middleway, we will need to install a new site access gate.

This work has now been paused and the footpath will reopen for public use on Wednesday 31 May 2023.

Three way stop and go boards

To remove the barriers and reopen the footpath safely, we will need to put in place three-way stop and go boards along a section of Curzon Street. This traffic management will safely protect our workforce, during this activity.

The stop and go boards will be in place on Wednesday 31 May. They will be operational from 9.30am until 3pm. Access to the canal will be maintained throughout.

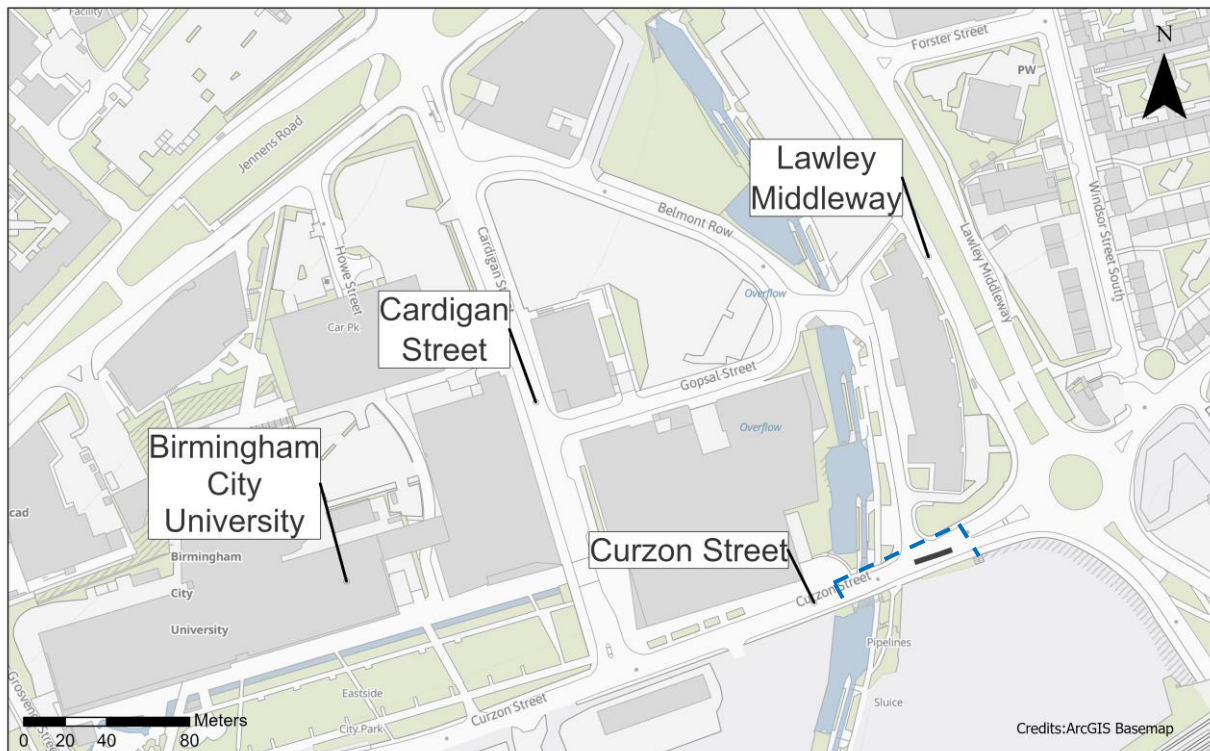
