Ground investigations at Richmond House garden

High Speed Two (HS2) is the new high speed railway for Britain.

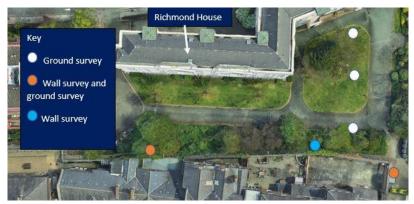
Surveys in garden of Richmond House - 30 May to 6 June

We are surveying the condition of the ground around our worksite to inform our works design. From 30 May to 6 June, we will carry out ground investigations in the back garden of Richmond House.

We will survey the ground in five different locations on the green and in the driveway, completing the work in one location before moving on to the next. We will use hand tools to dig a shallow trial pit before using a large rig to survey the ground below. We will reinstate the ground after each survey.

You may notice periods of increased noise whilst we break out any hard surfaces for the trial pits and use the survey rig. We expect the noisiest work will take about two to three hours a day. We will use acoustic blankets to limit noise and will monitor the works closely to ensure we operate within approved noise limits.

We will also inspect and take samples of the brick wall at the back of the garden.



In June we will carry out a similar survey of the wall at the back of Silsoe House. Our team will work from the Barracks side of the wall but we will require access to the garden of Silsoe House to monitor progress and repair the wall after the survey. We don't expect this work to be noisy.
