High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will do

As we progress the construction of the new railway we will need to divert and protect utilities located alongside and across Bangley Lane. Before we can plan these utility works we need to undertake surveys along Bangley Lane to assess the location of utilities and their current condition.

When the work will take place

To complete these works safely we will require the closure of Bangley Lane on 30 May, 2023 between 8am to 6pm. During this time access will be maintained for residents.



Duration of works

Temporary one day closure of Bangley Lane on 30 May 2023.

Our working hours will be 8am-6pm.

Our workforce can be on-site one hour before and after to set up and secure our equipment.

Low-level noise from our machinery.
