High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To enable the construction of the new railway we will need to undertake utility surveys to assess the location of buried services, prior to undertaking any required diversion works. To ensure the safety of the public and our workforce, we will install a temporary closure of Flats Lane.

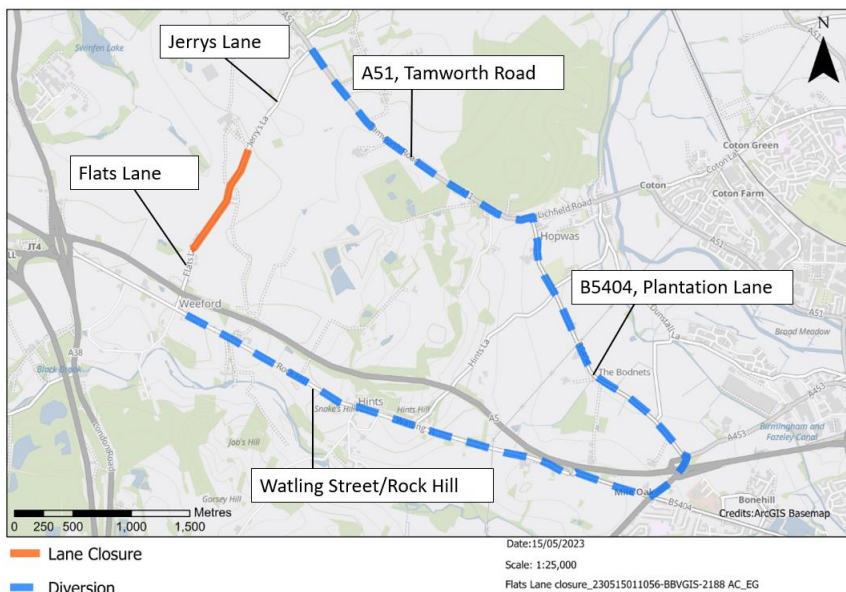
When the work will take place

These works will take place on 5 June and 6 June 2023. The closure will be in place between 9:30am to 3pm each day.

Access to properties will be maintained during this closure.
