High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will do

As we progress the construction of the new railway we will need to divert and protect utilities located alongside and across Rookery Lane. Before we can plan these works we need to undertake surveys along Bangley Lane to assess the location of utilities and their current condition.

When the work will take place

To complete these works safely we will close Rookery Lane on 31 May 2023, between 8am to 6pm. During this time access will be maintained for residents.
