The work we will be doing

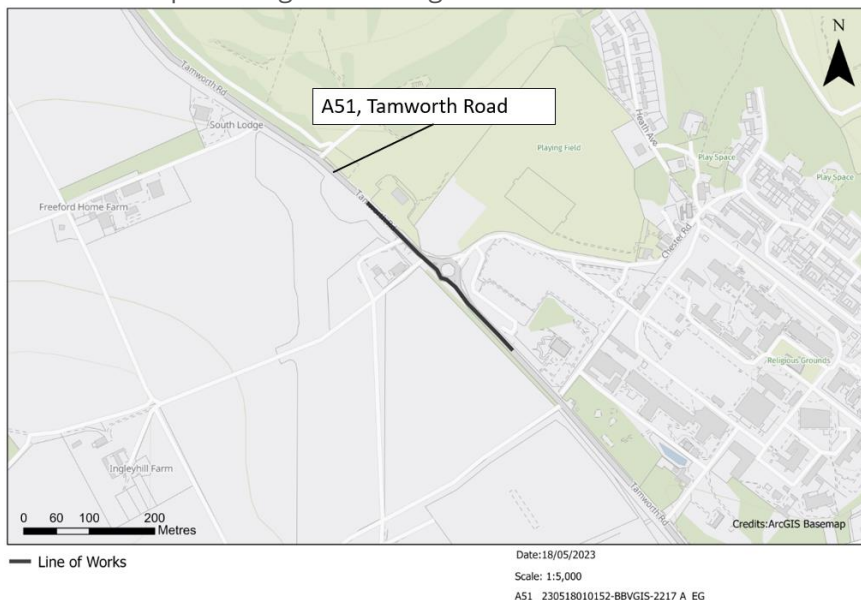
