High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area


The work we will be doing

The new railway will pass over the M6 on a viaduct and bridge structure. As we prepare for construction, we will first need to implement a series of safety measure on the motorway. Overnight between 14 June and 19 June we will be installing a temporary safety barrier and repainting the road markings to create narrow lanes. The motorway will be closed from 9pm until 5am the following morning.

From the 19 June, for a period of two years, this section of motorway will have narrow lanes and a 50mph speed limit.

M42 Diversion

Traffic wishing to exit the M42 on to the northbound carriageway of the M6 will be directed up to Junction 9 of the M42 then back down the southbound carriageway of the M42 exiting on to the M6 at Junction 8.



Duration of works

For five nights from 14 - 19 June 2023. The work will take place from 9pm at night until 6am the following morning

Narrow lanes and 50mph speed limit from 19 June 2023 until lune 2025

What to expect

Longer Journey times following diversion -Please allow 15 minutes.

A fully signed diversion Low level noise from our works



M6 North Diversion

Northbound traffic on the M6 will be directed to exit at Junction 4 onto the A446 to Junction 9 of the M42. Traffic will then directed south down the M42 exiting at Junction 8 then back on to the northbound carriageway of the M6.
