What are we doing?

In June 2023, we will be carrying out topographical surveys along Quainton Road. These surveys will be used to finalise designs regarding track drainage, land drainage and watercourses. They are expected to take two days to complete.

A topographical survey is an exercise undertaken by land surveyors using highly specialised equipment. These surveys provide detailed maps of land, identifying both natural and man-made features within a specified area.

In order to complete these works, a section of Quainton Road will be closed for approximately two days. This is for reasons of safety as our operatives will be working on and around the carriage way.

When will these works take place?

A section of Quainton Road will be closed 24-hours a day from Wednesday 7 June to Thursday 8 June 2023. Signed diversions routes will be put in place.

These dates may change due to conditions outside of our control. Please refer to the HS2 website regularly to check for any changes and updates.

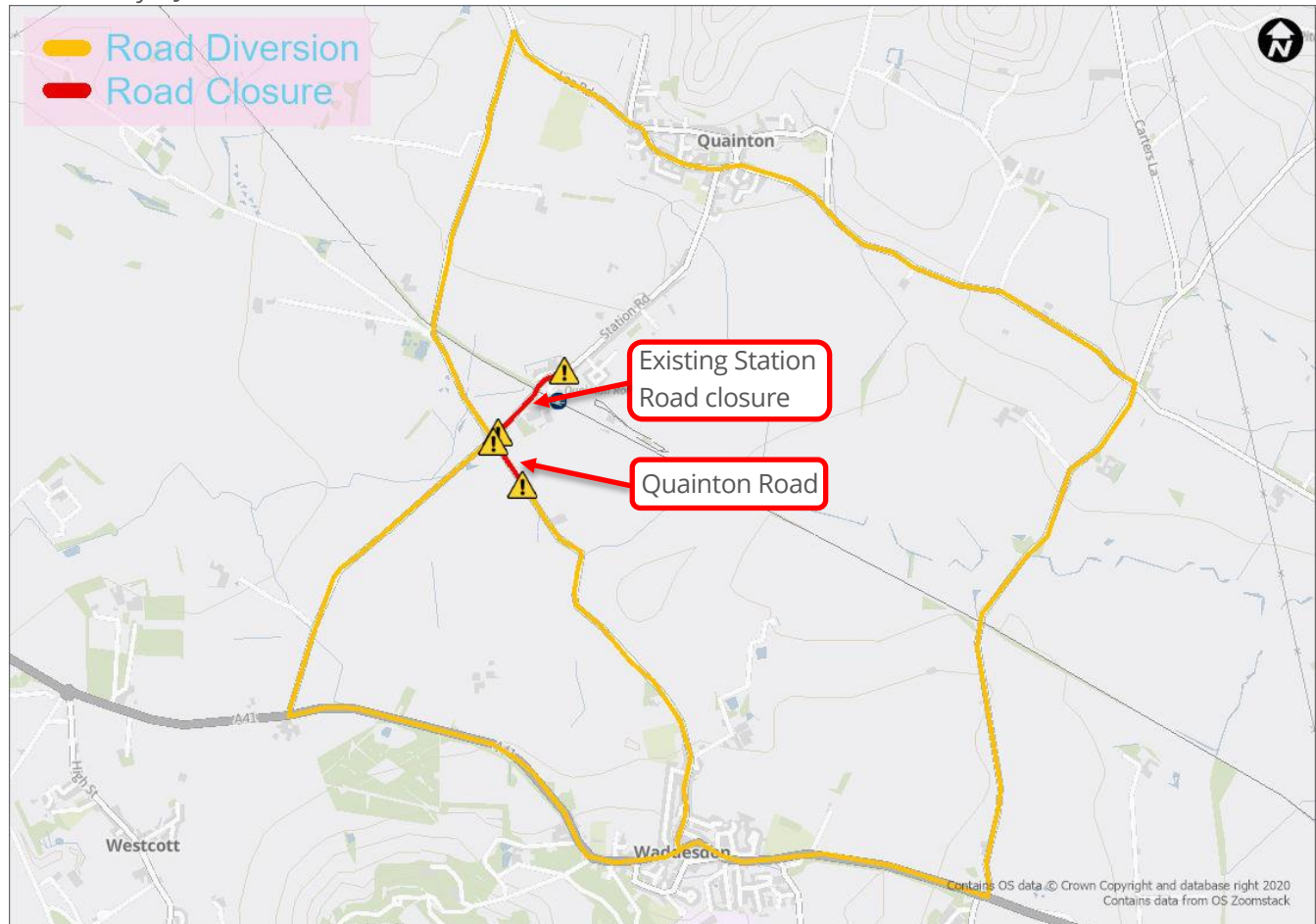

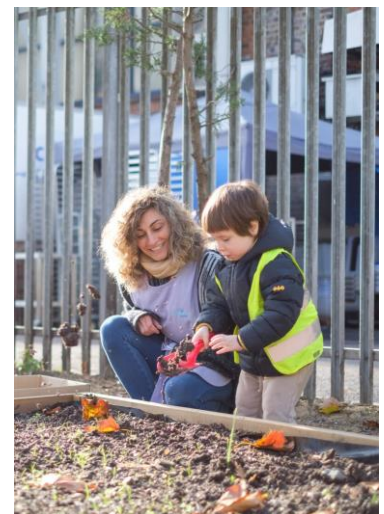
About our Community and Business Funds
