# **Update: Piling in Camden Cutting north**

High Speed Two (HS2) is the new high speed railway for Britain.

## Piling in Camden Cutting north until September 2023

We are currently installing piles at the northern end of our worksite, in the narrow space between the tracks and the retaining wall.

We have been piling in the area marked in orange since April 2023. In June we will move onto the section closest to Parkway, marked blue. Piling in this area will continue until September 2023.



For safety, some of these piles can only be installed at weekends when the tracks are not in use. We will let you know which weekends we are working closer to the time.

We will continue to receive deliveries to our worksite via the lorry lay-by on Park Village East north. You may notice periods of increased noise from the piling rig and excavator. We will monitor our works closely to ensure we are operating within approved noise and vibration limits.

Our working hours are Monday to Friday 8am to 6pm and Saturday 8am to 1pm. However, we need to complete the concrete pour for each pile within a single shift. This means we will sometimes work until as late as 10pm to finish a pile.
