

Works on Park Village East – 5 to 30 June

High Speed Two (HS2) is the new high speed railway for Britain.

Southbound traffic only on Park Village East between Parkway and Augustus Street – 5 to 30 June

We are currently replacing our hoarding at the southern end of Park Village East.

On 5 June we will begin replacing the final section of hoarding on the corner of Park Village East and Mornington Street bridge. We will close a section of the lane and footpath next to the hoarding and suspend 10 parking bays just south of the bridge. We expect these works to take about three weeks to complete

From 5 to 30 June, vehicles will only be able to travel south on Park Village East between Parkway and Augustus Street. Due to the lack of road space, vehicles will not be permitted to travel north from Augustus Street to access properties. We apologise for any inconvenience this may cause to the local residents. Cyclists will still be able to travel in both directions.

We will then return to the section of hoarding opposite Richmond House to install the graphics. We will require a footpath closure and parking bay suspensions for two weeks.

We expect these works to be complete by 30 June. We will notify you if we need to extend the duration of the one-way system.

Drain survey on Park Village East – 21 June

We will also carry out a survey of a drain on Park Village East close to Augustus Street. We will need to close a small section of the footpath and suspend five parking bays on Park Village East. We expect this work to take one day.

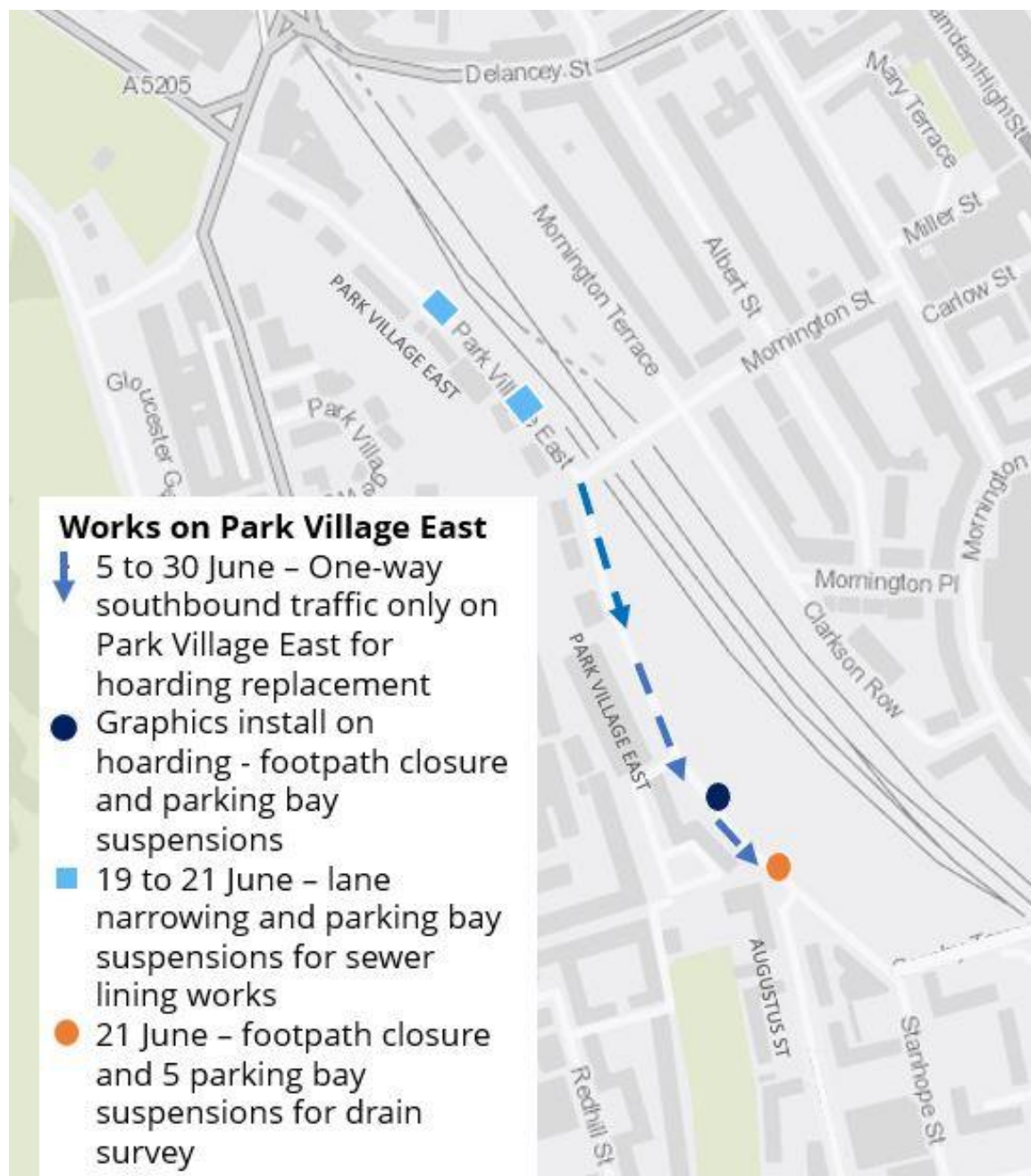

Sewer lining on Park Village East north – 19 to 21 June

We need to complete the works to strengthen and protect the utilities beneath Park Village East. On **19 June** we will install a lining within the sewer at the northern end of Park Village East via existing manholes in the road.

We will suspend parking bays and narrow the lane in front of properties 16 and 22 to 24 Park Village East to safely access the manholes. We don't expect these works to be noisy.
