Update notice of Saltley current and upcoming works -**Birmingham**

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

To allow us to continue to construct the new HS2 structures in the Saltley and Alum Rock area, the following road and footpath closures are planned to take place over the coming months.

Pennine Way

From Monday 22 May, for approximately three weeks, the junction of Pennine Way and Saltley Viaduct will be closed to enable a gas main diversion. Businesses within Saltley Business Park are advised to use the Arley Road entrance/exit.

Saltley Viaduct

We previously informed you know that utility diversion works are currently taking place overnight along Saltley Viaduct. These works require a full closure of Saltley Viaduct and take place from 10pm – 6am Monday to Friday. In addition to these works, there is a requirement for temporary two-way traffic signals on Saltley Viaduct between 9.30am – 3.30pm Monday to Friday. These will be in place from 25 May for approximately three weeks.

Crawford Street

From Monday 22 May, we need to close the junction of Crawford Street and Saltley Viaduct to continue with utility diversions and construct a new site entrance. This closure will be in place throughout construction.

Adderley Road and Cranby Street

From Monday 22 May, for approximately three weeks, a series of temporary traffic signals will be in place along Cranby street and Adderley Road. This is to enable our team to safely divert utilities. Access to businesses and properties will be maintained throughout these works.

Ensure that our work areas are safe and secure.

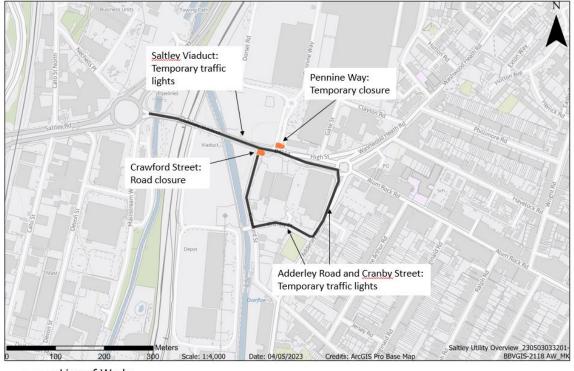
