High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

What we are doing

We previously informed you that utility diversion works would be taking place along Saltley Viaduct. These works require a full closure of Saltley Viaduct from 10pm – 6am, along with temporary two-way traffic signals from 9.30am – 3.30pm Monday to Friday and will be ongoing until summer 2023.

Due to the need to complete emergency works on the gas main we will now need to also install temporary two-way traffic signals on Saturday 3 June between 8.00am and 3.00pm.

Ensure that our work areas are safe and secure.


