



Notice of overnight road closure - A452 southbound - Bickenhill

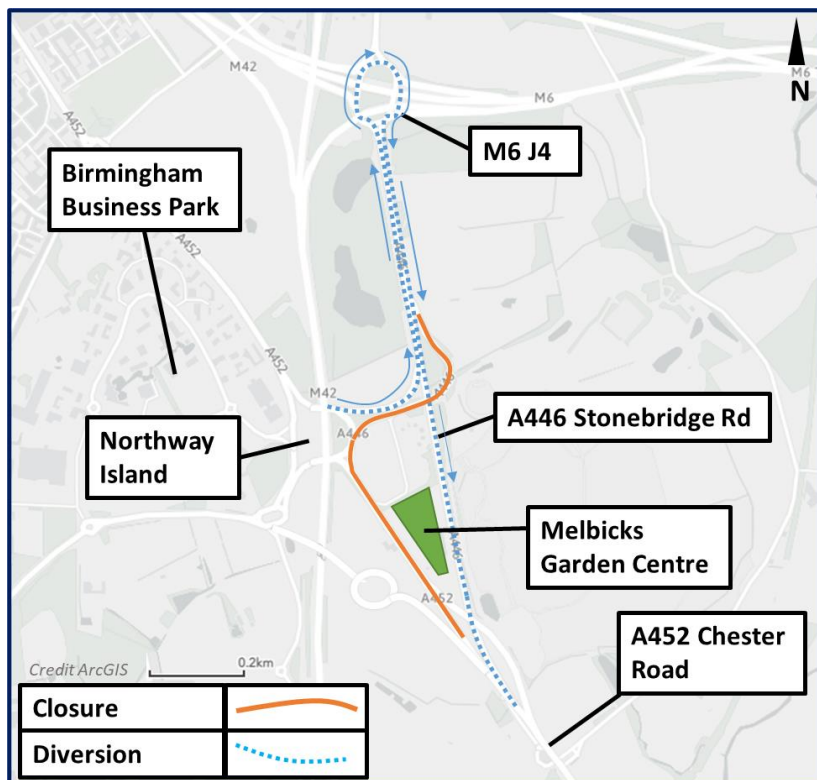

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

The work we will be doing

BBV have been significantly reconfiguring the junction of the A446 Stonebridge Road and A452 Chester Road near Birmingham Business Park to facilitate the construction of a bridge that will take the new railway over the M42. Between 30 May and 8 June, we will need to close the southbound carriageway, including the southbound slip road to install a new footpath and new road surface. To minimise disruption to residents and business we will only close the road from 8pm at night and reopening at 6am in the morning. A fully signed diversion will be in place.

Duration of works

Overnight from 8pm until 6am from 30 May until 8 June.

What to expect

Low level noise from our work.

Our work force maybe on site one hour before and one hour after the closure.

Fully signed diversion.

Short delay to journey times following diversion – allow 5 minutes.
